I. AWARD OF THE SILVER STAR: -..... By direction of the President, under the provisions of Army Regulations 600-45, 22 September 1943, as amended, the Silver Star Medal is awarded to the following:

BENJAMIN F. MONTAGUE, Ol 301 859, Captain, Infantry, Company B, 242d .

Infantry Regiment, for gallantry in action on 9 January 1945 at Hatten, France.

Despite two fanatical enemy attacks on his Company's position by infantry, supported by flame throwing tanks, artillery, and mortar fire, Captain Montague remained in position and directed his company's defense against the enemy. When his position was in danger of being overrun, he organized the sixteen remaining men of his company and ordered them to proceed to Hatten, France, and set up new defensive positions. He then remained with the woundedmen until subsequent capture by the enemy. As a result of Captain Montague's gallant and courageous action, his men were inspired to greater efforts, enabling his Battalion to set up strong defensive positions around the town of Hatten. Entered military service from Belle Mead, New Jersey.

II. AMARD OF THE ERONZE STAR MEDAL: -... (a) By direction of the President, under the provisions of Army Regulations 600-45, 22 September 1943, as amended, the Bronze Star Medal is awarded to the following:

HAROLD R. LILES, O 556 794, First Lieutenant (then Second Lieutenant), Infantry, Company H, 232d Infantry Regiment, for heroic achievement in action on 25 January 1945 near Schweighausen, France. During the attack on Schweighausen, Lieutenant Liles moved forward in the face of intense mortar and artillery fire to observe and direct our mortar fire on the enemy. The fire was so intense that at times he was forced to take cover in the freezing water of a nearby stream. After the town had been taken, he refused to leave his platoon although suffering from cold and severe exposure. Lieutenant Liles! outstanding courage and leadership played a major role in the successful capture of the town. Entered military service from Stillwater, Oklahoma,
