L. A. Chapter Remembers

In May of 1919, the three Companies of Engineers that California had contributed to Rainbow from its' National Guard was returned to their home areas and "kicked out" of Federal service. Company D went home to Sacramento, while E and F wound up where they had started: in Los Angeles.

A quickly-formed L.A. Chapter of our R.D.V. learned that relatives had maintained "Company" Auxiliaries during the war; by agreement of all of the "vets," the first order of business of the Chapter was to convince the membership of those "Company" organizations that they should become even stronger... as a single entity. That turned out to be "a labor of love;" sure enough, they did become one entity, limited in membership to the female of the species! (Odd, isn't it? Our National Auxiliary as we know, appreciate, and love it today, had its' birth at the Los Angeles Reunion of 1932.) But, back to 1919:

The new Auxiliary presented the Chapter with a set of Colors, the "Standard" having been designed by Naomi Littell (wife of Frank, F-117 Engrs), if this Scribe's memory is worth a damn! On November 11, 1919 . . . first anniversary of the WWI Armistice . . . those Colors made their first public appearance as they led the parade down the main thoroughfare of the city. Contrary to custom, that "Standard" was not cluttered up with names and dates. Rather, on a field of pure white banner silk, one noted only a beautiful multicolored rainbow arching above the figures "42" in exquisite blue.

After meritorious service, some 41 years and five months later, the entire set was retired and replaced by exact duplicates (except that by December of 1960, our United States had done a bit of growing that required additional Stars in the field of Old Glory.) Again, we were indebted to the Chapter's Auxiliary; a finer Christmas gift is unimagineable!

The above photo was removed from the official pictorial history of the Los Angeles Auxiliary. It will, of course, be returned. Taken by Rainbower Ron Roberts (E-168 Inf) it shows the President of the Chapter, William S. Miller (on the dais in the background) with the two most important "officials" present, surrounded by a couple of guys who simply went along for the ride. The lady on the left is Bea Justad, Chairlady of the Auxiliary's committee to secure and present the Colors. At right is Fanny Christopher, then President of the Auxiliary. The others, who cares? Actually, on the left is "Stoney" Stonebarger, Chapter Sergeant-at-Arms, and on the other side, some folks will recognize a member of the Chapter's Executive Committee, "Slim" Sutherland.

The original "Standard," properly identified . . . framed . . . and under glass, is presently on display in the home of VFW Post 8310, in Burbank, California.

Kubik Honored

In answer to your inquiry on Bob Kubik, I received a telephone call from John Sabo, one of the stalwarts of "G" Company, 222d Infantry, on 2 June, 1979, at approximately 9 p.m., informing me of Bob's passing. Over the next hour, I tried unsuccessfully to contact the family. It was the same story the next day; a telephone recording gave me another number to call, but no answer. Saturday night we contacted Jim McNicol, who also took steps to contact the family. Jim had flowers sent on behalf of the organization, along with appropriate sentiments.

At Huntsville in July, the Regimental Association passed an unanimous resolution to send Bob's family an engraved certificate honoring him for his devotion to the 222d Regiment and the 42nd Division. In addition, there is an ongoing program to contribute funds to the Gruber Memorial in his name. To date, contributions amount to \$358.00, and it is hoped that more funds will be forthcoming. Please mention this project in your next Issue so that all who knew and respected Bob's efforts on behalf of Rainbow may contribute to his honored memory.

Bob's death is a great loss to his loved ones, and all of us who knew him as a first class soldier will hold his memory in high esteem.

Pension Urged

The following Resolution, passed at the 1979 Convention of California Retired Officers Association, will be of interest to veterans of World War I:

"WHEREAS, The fighting men who braved the dangers of barbaric warfare during World War I have been ignored by the present members of Congress even though they were the ones who founded the American Legion, Veterans of Foreign Wars and the Disabled American Veterans, and

"WHEREAS, Many of these veterans received disabilities from the use of gas which did not completely dissipate, and

"WHEREAS, These veterans have had to fight for every penny of recompense they receive for their wartime service, and

"WHEREAS, These veterans are now at least 82 years young, thus qualifying as elderly people, now therefore

"BE IT RESOLVED, That the Retired Officers of California, assembled at Palm Springs this 22nd Day of September, 1979, urge Congress to pass a Pension Bill for the few remaining World War I Veterans."

Some six hundred copies of the Resolution were mailed to the President, members of Congress, Department of Defense and to TROA Chapters through the country.

Nuclear Info

For over a year, the Department of Defense has been attempting to identify former military and civilian Defense personnel who participated in the atmospheric nuclear tests conducted from 1945 to 1962. If you participated in these tests, which were held largely in Nevada and at Bikini and Eniwetak atolls in the Pacific, you are urged to contact the Defense Nuclear Agency if you have not done so.


Based upon research to date, it is believed that radiation exposures were low. While medical science has no proof that exposure to radiation levels as low as these is hazardous to health, it is generally assumed by scientists that even low levels of exposure carry some slight risk.

If you were a participant in the atmospheric nuclear test program, and you have not already done so, you are urged to contact the Defense Nuclear Agency at toll-free number 800 - 336 - 3068 in the continental United States; from Virginia, outside the Washington, D.C. area, call toll-free 800 - 572 - 6845; from Alaska and Virginia within the Washington D.C. area, call 202 - 274 - 9161 (collect if long distance); from Hawaii call collect 808 - 422 - 9213. Or, write to Defense Nuclear Agency, Washington, D. C. 20305.

If you are concerned that your possible exposure may have adversely affected your health, you are urged either to consult your doctor or contact the nearest Veterans Administration Hospital, where you may obtain a physical examination at Government expense.

In November, a California veteran, suffering from cataracts and advanced cancer, won damages in court against the Government, based on the fact that he had been witness to a nuclear test, which "probably" was the cause of his illness.

A Year of Progress

"The completion of a full year of occupation duty in Austria by the 42nd Infantry 'Rainbow' Division, Commanded by Maj. Gen. Harry J. Collins, calls for a review of the Division's many accomplishments since VE Day. During the twelve months that have passed since the shooting stopped, the 42nd and other US troops in Austria have faced and solved problems which, in complexity and difficulty, have rivalled combat days".

Thus begins the fascinating and amazing report of the 42nd Division's accomplishments in that first year after the war ended to help the American Zone of Austria return to normalcy following a devastating war. Writes PNP Hugo Grimm:

Perseverance Pays

The battle by Col. Walter T. Collins, USMC, Ret, to receive the Distinguished Service Cross reached a fruitful conclusion September 28, 1979, when Army Assistant Secretary Robert T. Nelson telephoned Collins to announce that the Army Board of Military Corrections had awarded him the nation's second highest medal.

Collins, now 80, was a 19-year-old private serving as a sniper in the 1st Battalion, 165th Infantry, of the New York National Guard's 42nd "Rainbow" Division in World War I when his long trek to the DSC began.

During a battle in the French town of Jonchery, July 15, 1918, Collins rescued three wounded soldiers before succumbing to mustard gas. He later received the Silver Star for his heroics, despite being recommended for the DSC by his commander.

Not satisfied with the lesser award, Collins began what he calls "constant badgering of the Department of the Army" for a hearing to correct the error.

Because his lone living witness, an 86-year-old amputee, could not come to Washington to testify in his behalf, Collins ended up hiring a camera crew to videotape the testimony. Col. Collins wrote a brief note to the Editor, "This took a long time, but it was worth it."

Armistice Day

Armistice Day was observed across the Nation on Sunday, November 11, 1979. Among those Chapters having special observances were the Mo-Kan Chapter, which assembled at the Rockhurst College Student Chapel in Kansas City at 11 a.m., for a Memorial Service conducted by National Rainbow Chaplain, Rev. Robert F. Weiss, S.J., President of Rockhurst College.

On that same Sunday afternoon, at 4:00 p.m., a Massing of the Colors and Veteran's Day Observance was held at St. Michael and All Angels Episcopal Church in Dallas, Texas. Twenty military and para-military units participated along with twenty partiotic organizations. Texas Chapter of the Rainbow Division Veterans Association was well represented with Clovis Brakebill (542 FA Bn.) acting as Grand Marshal, Co-Chairman of the Massing of Colors Committee, and led the congregation in the Pledge of Allegiance. The National Rainbow Banners were carried by PNP Johnnie Stubbs (D-242 Inf) and Arnold Hofland (M-232 Inf).

San Francisco Folds



The San Francisco Chapter of the Rainbow Division Veterans Association has place its allegiance with the Los Angeles Chapter, and placed its colorful 44-year old Banner and United States flag with the California Veterans Home Museum in Los Angeles.

Henry Steuhmeyer of Petaluma, President of the Transbay Chapter, made the announcement and contribution in collaboration with LTC (Ret) G. L. "Chick" Evans of Napa, retired Colonel-Commandant of the Veterans Home, and an associate member of the Veterans Home Historians, sponsor of the Museum.

Steuhmeyer said the San Francisco Chapter, once having a Northern California membership of about 200 World War I men, had scaled down "to about 30 living in all parts of the United States."

Rather than disband, Colonel Evans reported, the Chapter decided to affiliate with Los Angeles, which now has the only Rainbow Chapter in California.
