"Vet Set" Invades Iowa!

Rainbow Takes Cedar Rapids

Although somewhat below the anticipated attendance, Rainbow Veterans increased the population of Cedar Rapids, Iowa, by some 514 persons during the 62nd Reunion of the Division Association on July 9 to 12, 1980.

Factors believed to have affected the planned-for six hundred or more registrants were given as inflation, extreme heat and total inertia. Actually, the group coped fairly well with the heat, and the Texas contingent was relieved to escape its record-breaking heat wave of 100-plus temperatures and bask.

The swimming pools of both hotels got a good workout, but the pool complex in the Roosevelt Hotel, with its game room and shops, appeared to be a heavy favorite. Also enthusiastically received were the splendid complimentary breakfast on the foyer level of the Roosevelt Hotel every morning, and the free cocktail hour each evening.

222d Infantry Takes the Champagne!

In answer to the challenge issued to the Infantry Regiments and Special Troops by the 232d Infantry Chapter at the Huntsville Reunion last year, the 222d Infantry turned out in sufficient numbers to win the attendance race and the champagne. Seventy-six 222d veterans signed, including fourteen of the YANKE (M-222) Chapter. The 232d Infantry had an attendance of fifty-three, and 242d Infantry had thirty-eight. The new Division Artillery Chapter was third with twenty-three, representing all WW II artillery units and DivArty. Other units represented were: 122d Medical Bn., 16; 42nd MP's, 11; 132d Signal Co, 8; 142d Engineers, 7; 42d Ordnance, 3; and 42nd Recon, 2. The new Muskogee Chapter had four in attendance.

Only thirty-nine World War I veterans were registered: Thirty from the 168th Infantry; 149th Field Artillery, 4; 165th Infantry, 2; and one each from the 117th Ammo Train, 150th Field Artillery and the 151st Field Artillery.

In Memoriam**Mary Roberts**

1973 -74 National Auxiliary President, Mary Roberts, of the Father Duffy Chapter, passed away of an apparent heart attack at the Cedar Rapids Reunion on Friday, July 11, 1980. Following the Annual Brunch, she had returned to her room, when she failed to return to the lobby, her roommate, Isabelle Metoskie, tried phoning, then went to their room to find Mary dead. Her prayer book was lying open nearby when she was found, and apparently she had been reading it just before she passed away.

A widow of thirty years, Mary Roberts had been an ardent Rainbower, active in both the Father Duffy Chapter and the National Association. She and Isabelle had attended the last fifteen Rainbow Reunions together. Her funeral was held in New York on Tuesday, July 15, 1980.

Harry H. Cory

Harry Harmon Cory passed Over The Rainbow in quiet sleep on June 13, 1980, at the age of 88, and was buried in Lakewood Cemetery, Minneapolis, MN, on June 17. Born in Frankfort, OH, he joined "E" Battery, 151st F.A. while living in Minneapolis, and served with the unit throughout WWI. Active for many years in National Rainbow, he is remembered by many as chairman of the Annual Reunion in Minneapolis in 1962. In 1977, Harry published a book entitled, "Humor," a collection of stories from Rainbowers and other friends.

Muskogee Memorial

After numerous meetings with city officials and countless estimates and much correspondence, the Rainbow Memorial Foundation is ready to provide the money and instructions to proceed with the completion of the Muskogee Memorial.

A minimum of \$32,000 will be required to complete the amphitheater, access road, grading, walkways, painting and installation of a granite Rainbow arch four feet high and eight feet long on the back of the amphitheater, night lighting and four hundred Rainbow colored seats of fiber glass. A reserve fund of some \$3,000 will be required to pay for work to be done by the city of Muskogee.

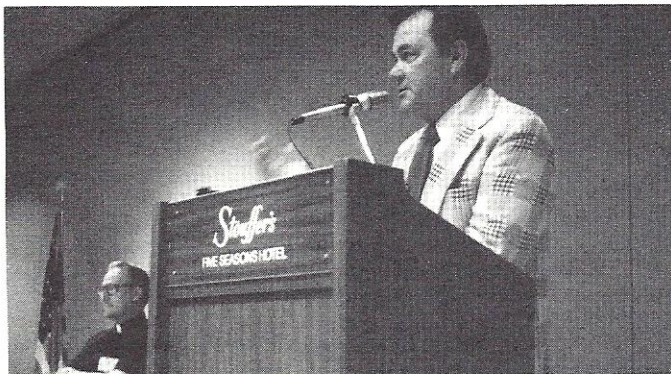
The Muskogee Memorial Fund now has a total of \$39,795, which will leave some \$5,000 after all the work has been completed, and the annual maintenance cost of over \$1,000 will be assumed by the city. The membership voted unanimously to approved the expenditure of Foundation Funds to complete the Muskogee Memorial.

New Charters Awarded

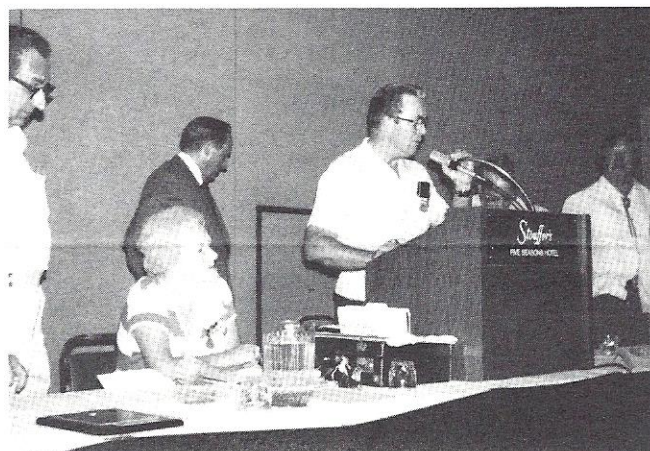

Chairman Gardner reported that the applications were complete and in order, and that the Charter fee had been paid. The membership unanimously approved the new Charters.

The 542nd Field Artillery Chapter applied for a new Charter in the name of Rainbow Division Artillery, to include members of all Rainbow Artillery units of both WWI and WWII. Walter Pierce (top right) accepted the Charter with an initial enrollment of 36 members. Twenty-three members of this new Chapter were in attendance. A great start, and they promise to double that membership by the next Reunion.



Another Dues Increase



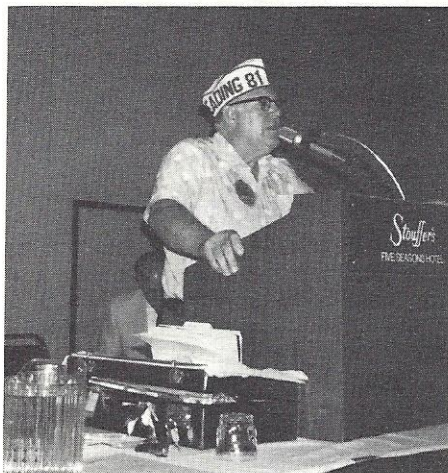
Following the presentation of the budget for the coming year (see page 6), Committee Chairman John Carr asked the membership to approve his budget and his request for an increase in National dues to six dollars per year starting in 1981-1982. He reasoned that with membership slipping each year (actually it was up this year over last year), we need more money from members just to meet expenses. During the somewhat heated discussion that followed, President Brewer stopped proceedings to confer with Judge Advocate Loyd Matson (above photo). Matson ruled that the Budget Committee could recommend a dues increase, but could not include it in their report. He stated that a dues increase would have to be acted on by the Constitution and By-Laws Committee, but Ted Johnson, Chairman of that Committee, stated that dues were not set forth in the Constitution, and that in the past, increases in dues were acted upon by a vote of the membership. Matson agreed after checking the Constitution, and the motion to raise dues was again presented to the membership and passed without opposition.

The 63rd Rainbow Division Veterans Reunion will be held in Reading, PA, on 8, 9, 10 and 11 July, 1981. Reunion Chairman Phil "Rainbow" Trout explained that the Abraham Lincoln Hotel, which will be Reunion Headquarters, can allot us only 160 rooms, and that the overflow will be billeted in the Holiday Inn, two miles away on Route 222. He requested consideration by any unit to place all their members at the Holiday Inn, but did not make the request specific to any unit. The Abe Lincoln Hotel would thus be available for the older folks and officers.

Later in the Reunion, the 222nd Infantry Chapter agreed to take over the Holiday Inn, permitting the Chapter to keep all their people in one place and have plenty of room to hold unit meetings. They plan to commute to the Lincoln Hotel for Association meetings with the help of shuttle buses provided by the Reunion Committee.

Addresses of the Reunion Hotels are: The Abraham Lincoln Motor Inn, 5th and Washington Streets, Reading, PA 19603; and The Holiday Inn of Reading, 5th Street Highway and Warren Street By-Pass, Reading, PA 19605. Rainbow Pays Respects to MacArthur

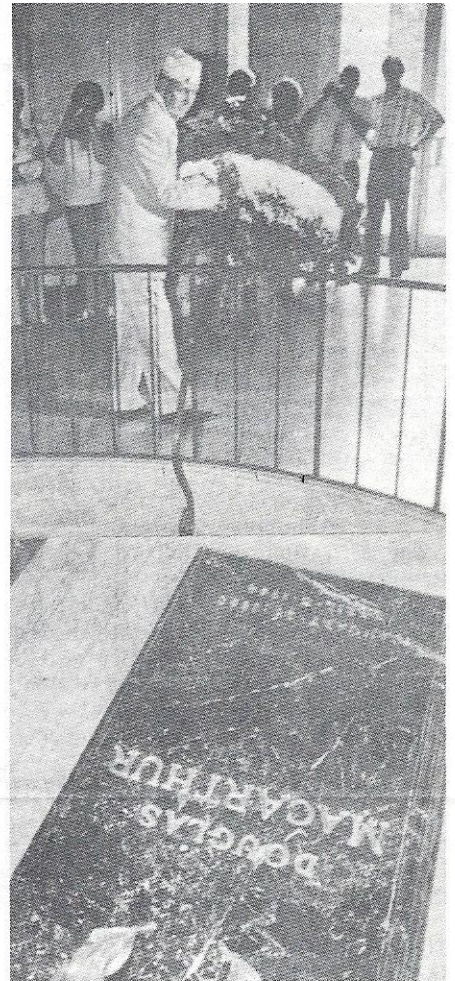
At the exact moment the Memorial Service for the Annual Reunion of the Rainbow Division Veterans Association began in Cedar Rapids, Iowa, a similar ceremony began to unfold at the tomb of General of the Army Douglas MacArthur, in Norfolk, Virginia.

Charles E. O'Shields (M-222 Inf), who has for years coordinated the Rainbow effort in support of the annual Memorial Service at the MacArthur Tomb, reports:

"The wreath laying ceremony at Norfolk was by far the nicest in many a year. Even the Rainbow wreath was more beautiful, larger and much brighter.

"Colonel Lyman Hammond, the Memorial Director, gave me his greatest support and assistance. He even made all arrangements for newspapers and television coverage. Mrs. MacArthur phoned from New York before the ceremony to thank all Rainbow veterans for the honor they bestow on 'my General.' She always speaks of him as 'my General.' She also mentioned that he always had a soft spot in his heart for the Rainbow.

"Her words were repeated by Colonel Hammond at the crypt during the ceremony. We did something different for the first time this year. The Rainbow Flag was removed from the wall of the rotunda and held at the rail of the crypt near the Color Guard from Fort Monroe. The flag was held by Robert W. Flora (H-222 Inf), from Chesapeake, VA."
