Veterans Day 1982



Sixty-four years ago this month, the war-weary Doughboys of the American Expeditionary Forces received the news that the war was ended. As the Rainbow Division paused to count its 12,617 casualties, there was no celebration. Wrote Col George E. Leach, CO, 151st FA, "The Armistice is signed and at eleven, A.M., the firing ceased. Nothing impressed me so much as the absolute silence."

Symbolic of all the American soldiers who have gone to war is Retired Master Sergeant Anthony W. Remza, 2100 Fairview Avenue, Mt. Penn, PA., who began his 34-year Army career as a private in 1917 with the 4th Pennsylvania Infantry at the age of 19. The 4th Pennsylvania became the 149th Machine Gun Battalion of the 42nd "Rainbow" Division in 1917. In WWII, he was a Master Sergeant in the Dutch West Indies, and served as a medic-corrective therapist in the Korean War.

In honor of his military service, M/Sgt Remza, at 82 years of age, was Marshall of the Armed Forces Day parade in Reading, PA, on May 15, 1982.

Rainbow Historian

Michael Kaehler, PO Box 83, Milaca, MN 56353, is a World War I historian and researcher who is very interested in the WW I Rainbow. He has tape recorded interviews with over ninety WW I veterans of various units, and is corresponding with approximately seventy-five others across the United States.

He is striving to collect enough detailed information on World War I to write a book on the war and the AEF, and is depending primarily on his interviews and correspondence with WW I veterans.

Kaehler would like to correspond with any WW I Rainbow veteran or his widow regarding service in France during that War, and would personally interview any WW I Rainbower living in Minnesota or within reasonable traveling distance.

He has been most helpful during the Editors research on the Rainbow Flags, providing photos and detailed information on command personnel and actions. Any assistance you can provide Mr. Kaehler would be greatly appreciated by the Editor.

In a letter just received, Kaehler writes that he has recently acquired a three-volume photo album containing over 300 Official and Signal Corps photos of World War I Rainbow from its arrival at St. Nazaire to the occupation of Germany. He has found photos of yet other Rainbow Flags in these albums:

Signal Corps #156532 pictures the division headquarters at Ahrweiler, with the Chief of Staff, Col. Wm. N. Hughes, and a different Rainbow Flag. This one is dark blue with yellow fringe border, and syellow "42" below a yellow-bordere. Rainbow. The picture is dated February 28, 1919.

Signal Corps #156516 pictures General Pershing reviewing the Rainbow on March 16, 1919. The Rainbow Flag in the photo is different from the one at Rolampont.

Mid-Year 1983

After seven consecutive years of Mid-Year Meetings in the Tampa-Clearwater area of Florida, President "Rube" Evanoff has heeded the numerous calls to move it to a new area and give the attendees something more than two days of hotel activities.

President Evanoff has announced that the 1983 Mid-Year Meeting of the National Executive Committee, RDVA, will be held on Friday and Saturday, February 25 and 26, at the Chamberlin Hotel on Chesapeake Bay at historic Fort Monroe, Hampton, Virginia.

Arrangements are being planned, with the assistance of the MacArthur Memorial Museum in Norfolk, for a group visit, and possibly a memorial ceremony, at the Memorial, about 30 minutes away.

A complete agenda, including a luncheon and banquet, will be published in the January Issue of REVEILLE.

The Chamberlin is offering Rainbowers a special rate of \$29 single and \$34 double, plus 8% tax. Those planning to attend must make their reservations direct to The Chamberlin, Hampton, VA 23651-0007. A check covering the first night's lodging should be included and mailed before January 25, 1983. The rates will also apply for those arriving before February 25, or staying later than February 26 - providing you indicate you are participating in the RDVA Mid-Year Meeting.

Hotel personnel will assist in planning tours to nearby Colonial Williamsburg, Jamestown, The Old Country at Busch Gardens and other places of interest.

All Rainbowers and Auxiliary are encouraged to attend what promises to be a most rewarding event. A registration fee of \$25 per person, covering costs of official events, should be forwarded as soon as possible to Chris Reilly, 1136 Court Revere, Odenton, MD 2113.


The MP's Brag!

Rainbow Arch Topples



The 1,600-pound granite Rainbow, which was an important part of the Rainbow Muskogee Memorial, crashed to the ground in pieces during the night or early afternoon of Tuesday, August 3. The \$3,500 structure, shown in the photo on page 3 of the September, 1982, Issue of REVEILLE, was totally destroyed.

The question now is, "Why did it fall?"

The city of Muskogee says it was caused by faulty construction and installation; the construction company that built and installed it claims it must have been vandalism, although a guard is posted on the site every night; this writer will reserve judgment until further word from the Memorial Foundation.

This is only the latest of many problems that has befallen the monument since the Rainbow Memorial Association began the project over six years ago. The total cost of the memorial amounted to over \$100,000. Contributed by Al Cahoon.

Those Rainbow Flags!

Over the past two years, the Editor, ably assisted by many others, has tried to unravel the numerous conflicting photographs of Rainbow Flags, written reports and remembrances somewhat dimmed by the passing years, and the result is that we have more Rainbow Flags than we know what to do with and the true identity of some of them is in serious doubt.

The first Rainbow Flag was presented to Douglas MacArthur by Mrs. William Cummings, a personal friend of his mother, at Camp Mills, NY, in September, 1917. The source of that flag and the presentation is substantiated by many reports.


Then, Michael Kaehler, a military researcher, purchased an old suitcase containing uniforms and a photograph album that belonged to Sgt. William Sheehan, 166th Infantry Supply Company. In the album, which contained photos covering all phases of Sheehans service with the Rainbow in WWI, was a photo of a Rainbow Flag; on the back of the photo was written, "October, 1917 - The Rainbow Division Flag at Camp Mills." See the photo at top center.

In a reproduction of that photo, it is apparent that the flag is white with dark lettering. Kaehler wrote that it is obviously the same flag that was pictured in the November, 1981, and March, 1982, Issues of REVEILLE. See photo bottom left.

Following the publication of those photos, David H. Brown, B-149th MG Battalion, wrote saying he recalls seeing the white Rainbow Flag at General Pershings farewell address to the Rainbow Division in March, 1919, along the Rhine River east of the Remagen Bridge. Later, he saw the same flag in a newsreel of WW I events. It was his opinion that when the division was deactivated at Camp Dix in May, 1919, Maj Gen Clement A. F. Flagler, then commanding, took the division flags with him.

However, a letter from General MacArthur in 1924 states that he took the Rainbow Flag to West Point when he was assigned as Superintendent in 1919, claiming that the flag was presented to the Division and "did not belong to either the Federal or any State Government."

When Gen. MacArthur was relieved of duties at West Point and assigned to duty in the Philippines in 1922, he had his personal belongings crated (including the flag) and stored in New York. And when, in 1924, National President J. Monroe Johnson invited MacArthur to attend the 1924 National Reunion at Columbia, SC, Mac Arthur wrote declining the invitation and stating that he would return to the US in 1925 and would ship the flag to the Headquarters of the Association at that time.

Finally, through the efforts of National Secretary Cortez Souter, the MacArthur Flag was received by the Association in December, 1926, and was carried in the parade at the 1927 National Rainbow Reunion in Des Moines, IA. At least one WW I veteran who marched in that parade, PNP Homer Gardner, remembers that it was a white flag, the same as the ones pictured in the REVEILLE.

Then, there is a break in the history from 1926 to 1939, when, at the National Reunion in Oklahoma City, OK, a new Rainbow Flag was presented to the Association by Mrs. Minnie M. Glossbrenner in memory of her late husband, Alfred D. Glossbrenner. The flag was dark blue with white lettering, and was used at every National Reunion until 1943.

Upon activation of World War II Rainbow Division on July 14, 1943, the Glossbrenner Flag was presented to General Collins and carried to Europe by the Division. There are written reports that the MacArthur (white) Flag was used to open the ceremony, but was then replaced by the Glossbrenner Flag. However, in all the Signal Corps photos of the ceremony we have access to, only the Glossbrenner Flag is shown.

At an Executive Committee Meeting on September 29, 1944, a new Rainbow Flag, also blue with white lettering, was presented to the Association by the Florida State Association. Presumably, this is the Rainbow Flag we have saluted at all National Reunions and Mid-Year Meetings since that date.

When the WWII Rainbow Division was deactivated on July 14, 1946, at the National Reunion in French Lick, IN, General Collins returned the Glossbrenner Flag to the Association. Also at that Reunion, the MacArthur Flag was brought out "and it was handled most gently and reverently as time had taken its toll of the beautiful colors and the heavy silk was breaking."


Two Rainbow Flags, one, the Glossbrenner Flag representing World War II, and another Rainbow Flag, dark blue with gold letters, representing WW I, was presented to the Liberty Memorial Museum in Kansas City during the Mid-Year Meeting on February 21 and 22, 1947.

In a letter to Dixon Rogers by Curator Mark Beveridge of the Kansas City Memorial, he states, "I have had lingering doubts concerning the actual age of the flag identified as being from WW I. No history of the two divisional flags was given to the museum when they were originally transferred here in 1947."


And there the matter will stand until someone comes forward with what remains of the fragile MacArthur Flag, if it exists at all.

But, there are more Rainbow Flags: Slim Sutherland has one in the historical files of the Division, apparently never used; there are several unidentified flags that were used at Reunions from 1919 to 1926 and while the MacArthur Flag was in New York for repairs; another flag used until the Glossbrenner Flag was presented in 1937. In the MacArthur Museum in Norfolk is yet another one that is half red and half blue, with the Rainbow quadrant in the center.

AND, then there is this thing, the subject of a newspaper photo dated April, 1918, and titled, "The Rainbow Division Flag at Sub-Treasury, NY City."

AMTRAK to Dallas

Leon Schenck of Michigan is planning in advance for the 1983 Reunion in Dallas, and has enlisted the aid of AMTRAK in finding a less expensive way of crossing the country in comfort. This is what he found:

The cost of AMTRAK from Detroit to Dallas and return in \$295 per person. The rate for 15 or more traveling as a group is \$222, based on these provisions: reservations must be made six months in advance, 10% deposit must be paid for the group 45 days in advance, and the balance must be paid at least fifteen days before departure.

The regular round trip rate from Chicago to Dallas and return is \$220, and the group rate is \$165. All these quoted rates are due to be increased approximately six percent soon.

The schedule is: leave Detroit at 8:30 a.m., arriving in Chicago at 1:05 p.m., where you change trains, and depart Chicago at 5:20 p.m., arriving in Dallas the next day at 1:30 p.m.

Leon is hoping that many of the Michigan people will pitch in to make this a good trip, and that more of the Midwest people around Chicago will join them there.
