Reunion Report

Five hundred and sixty Rainbow faithful trekked to Dallas for the 1983 Rainbow Reunion and found more than adequate facilities ready for them. True, the noble plan of billeting units together didn't quite work out in the final rush to get folks into rooms. But then, it has never worked yet when people don't get their reservations in early.

Everyone was in a huge campus-like facility exactly as shown in the May, 1983, REVEILLE, with two swimming pools, a grand ballroom where the business meetings were held, and a Convention Center with more meeting rooms than were needed by Rainbow.

It would be difficult to imagine a more perfect motel-convention arrangement than we had at Dallas. The large Convention Center sits inside the circle of motel buildings, and contains a large conference hall, a spacious entry-lobby and wide hallways. The buildings and grounds were beautifully maintained and groomed, and offered pool-side lunches under canopies, which relieved the crowded dining room considerably. The Reunion Committee did a fine job of getting everyone taken care of with badges, tickets and Reunion packets.

Altogether, a very well-run operation and a very enjoyable Rainbow Reunion.

Meetings Were Short

The Executive Committee Meeting on Tuesday morning, and the three general meetings on Tuesday afternoon, Wednesday morning and Thursday afternoon were short and well-controlled by President Evanoff. The Executive Committee Meeting lasted only an hour and a half, and the roll call by Secretary Peg Keating found nineteen officers in attendance, along with fifteen state committeemen, ten unit committeemen and twelve members at large. The Secretary reported a final membership count for the year of 2,655, a loss of 124 members from last year.

The Treasurer's report, 1983-84 Executive Committeemen, Memorials Foundation officers, 1983-84 budget and Living PNP's may be found on page 6.

The three business meetings consumed a total of five and one-half hours, and all scheduled business was settled to the satisfaction of most in attendance. For the most part, the meetings were occupied in hearing reports and making such decisions as were required, but there were some few reports that raised arguments.

Planning Task Force

J. Wm. "Bill" Keithan, Chairman of the Long Range Planning Task Force, presented a resume of his 54-page report, compiled from the information gleaned from lengthy questionnaires completed by about half of the officers and PNPs to

whom he had mailed them.

Foremost was the recommendation that a chain of succession to the Presidency be established, and that the Constitution and By-Laws be changed to permit the election of a President Elect to serve one year before assuming the Office of the President. Although the Rainbow Auxiliary has had this system for many years, as had the 222d Infantry Chapter and countless other organizations, there are those who howl every time a change even for the better - is introduced. And howl they did when PNP Ted Johnson, Chairman of the Constitution and By-Laws Committee, introduced the change. However, a standing count showed the change to have passed by a fair margin.

The naming of a President Elect was delayed until the next National Reunion, because there was no time for the Nominations Committee to Act. Thus, next year, the Committee will nominate both a President and a President Elect. In future years, only the President Elect will be nominated, in that the President Elect for the previous year will automatically move into the President's chair.

Some of the other recommendations by the Task Force that hopefully will be acted upon by future Reunions included:

1. Institution of a Life Membership Program. Membership Chairman Dixon Rogers has been beating the drum for this many years, and President Evanoff directed the Treasurer to look into a dues schedule and report to the next Reunion.

Luncheon Speaker



Chaplain Robert P. Taylor Maj. Gen. USAF-Ret

General Taylor is a native Texan who was commissioned and sent to the Philippines in 1940. He was a captain when the Japanese attacked Pearl Harbor in December, 1941, and was in the Bataan Death March after Corregidor fell to the Japanese. A prisoner of war for three and one-half years, he served as chaplain to more than 10,000 wounded prisoners from 1941 to 1945. In 1944, General Taylor was placed in solitary confinement for fourteen weeks for smuggling food and medicine to injured American prisoners.

When he retired in 1966, he was Chief of Chaplains of the US Air Force. His decorations include the Silver Star, Distinguished Service Medal, Bronze Star and Presidential Citation w/20LC.

For his inspirational talk, General Taylor took his theme from the red, white and blue of our National Colors and likened each of those colors to elements of patriotism and duty to country. His message was warmly received by the packed room of Rainbowers.

- 2. Incorporate the Foundation's activities and funds into those of RDVA to aid and assist in perpetuating Rainbow.
- 3. Require that members must pay national dues only through a chapter of his choice.
- 4. Simplify the Executive Committee by limiting membership to appointed officers, the president and secretary of each chapter, and Past National Presidents.

Bring in the 42d NYNG?

In response to Keithan's questionnaire, there were as many answers to this question as there were responses. Some backed opening membership in RDVA to current and future members of the NYNG, without stopping to examine the consequences. First, our Constitution and name would have to be changed because those soldiers are not "veterans;" they are, according to a combat veteran and ranking noncom of the present 42nd Division, kids (boys and girls) off the streets of New York City more interested in avoiding a draft than in patriotic duty. There is a sprinkling of war-seasoned officers and noncoms in the NYNG who are certainly veterans, but not of Rainbow.

You haven't heard the end of this debate yet, and if someone can come up with a good solution, come forward with it. We really need your help.

"Ban Unit Chapters"

The results of Keithan's questionnaire were very revealing. For example, the distrust - if not outright animosity - toward unit chapters reared it's ugly head in comments like: "Ban unit chapters; prohibit unit chapter meetings and their separate programs!" "Require that all members of a unit chapter must pay dues to a regional chapter." "I think some of the unit chapters are trying to control Rainbow."

While unit chapters are trying hard to increase membership, they still account for less than half of the total Rainbow membership. The continued growth of "mail order" unit chapters could be predicted with the influx of WW II members who are strewn from coast to coast and have little chance of attending a chapter meeting until the annual Reunion rolls around. This Editor, for instance, lives nearly 400 miles from the nearest area chapter, and the only chance for maintaining touch with fellow veterans are the chapter newsletter, the REVEILLE and the annual trip to the national reunion. There is room - and need - for both types of chapters.



Gen. Robert T. Gill

The young "soldier," smartly decked out in his WWI khakis, marched into the dining room of the Broadview Hotel in Baltimore. The staff looked at his outfit in some surprise, but to the occupants of the dining room, every item of the young man's clothing seemed familiar.

The date was June 23, 1983, and the occasion was the semi-annual reunion lunch of the 117th Trench Mortar Battery of the Rainbow (42nd) Division. Those present included four WWI veterans of the 117th: Tom Price, James Cassidy, Joseph Isaac and Courtney Brown, plus wives and widows of other veterans, and friends.

This meeting of the Rainbow veterans had a more serious tone than usual because the 117th was mourning the loss of its Commanding Officer, General Robert J. Gill, who died on June 22 at the age of 94 after a long illness. As a young captain in 1917, Robert Gill led the 117th through its training and during active service in France until he was attached to the general staff of General Douglas MacArthur near the end of the war. He went on to have a long and distinguished career in both military and civilian life, and his former comrades remembered him with pride as well as affection.

This luncheon was also memorable because of the presence of the young "soldier" in uniform. He was Frederick Maisel, who teaches history at Boy's Latin School, but who also indulges a passionate interest in the Great War by giving demonstrations and lectures for schools and other groups.

From relatives who served in WWI and other sources, Mr. Maisel has collected an impressive amount of information and also many artifacts of the period. His uniform was correct in every detail, from his overseas cap and his iron derby to his fully equipped back pack, ammunition belt, gas mask, first aid kit and Springfield Rifle. The only things missing was the patina of mud characteristic of the uniform of the field, and the hobnails in his boots, which, Mr. Maisel explained, he had finally removed after several complaints of damaged floors after previous demonstrations. The uniform was also missing its resident community of everhungry cooties: Mr. Maisel's passion for authenticity did not-praise be-go that far!

Every detail of the uniform was of course familiar to the veterans present. Mr. Maisel did not have to tell them about the itchiness of military wool or the complications of trying to tie puttees, but the demonstration brought back many memories.

The loss of General Gill was a sad reminder to the veterans of time passing.

Rainbow Resolution

Past National President Howard Smith introduced the following Resolution, which was passed unanimously on the first reading:

Assembled in Reunion at Dallas, Texas, 11-14 July, 1983, We the Veterans of the 42nd Infantry "Rainbow" Division of World War I and World War II, join in petition to the United States Senate and the United States House of Representatives.

WHEREAS, Soviet leaders have demonstrated an intent to impose their ideology and control on any nation, such as Afghanistan, Poland and Angola, where they saw they could do so without effective retaliation; and

WHEREAS, Until recently, there has been a serious decline in the military capabilities of the United States while the Soviets have been greatly expanding their arms capabilities in all areas far beyond legitimate defense needs, and now surpass the United States in both strategic and conventional forces; and

WHEREAS, The Soviet Union has failed to adhere to peace and other agreements entered into with the US regarding limitations on strategic weapons; and


WHEREAS, We are dealing with a nation that has demonstrated a failure to adhere consistently to treaties and agreements which support world peace; and

WHEREAS, The Soviet Union has not hesitated to take aggressive action of many kinds, including subversion, against the interests of the United States and its allies; now therefore be it resolved that:

For the United States to negotiate effectively, it is essential to be in a position of strength as opposed to weakness. We, the members of the 42nd Infantry "Rainbow" Division Veterans Association, urge each member of the United States Congress to fully support the goals and aims of the President to rebuild the United States military strength in order to counter the Soviet Union's arms buildup and to protect the security of the United States and its citizens.

As combat veterans of two wars, we recognize the fallacy of "second best," as was our position at the beginning of both World War I and World War II. We must never again permit this nation to descend to such a position. Military preparedness that results in a credible military strength for this nation is our surest road to Peace.
