# Auxiliary Shocked At Death Of President Lora A. Butt

The untimely death of Auxiliary President Lora A. Butt on September 15th has deeply affected the Auxiliary members and those Rainbowers who were privileged to know her personally.

Lora suffered a massive heart attack on September 12th, exactly two months after the joyous occasion of being installed as Auxiliary President at the National Reunion banquet in Oklahoma City on July 12th. Although paramedics responded promptly, Lora had suffered considerable brain damage and was in intensive care until her death on September 15th.

There is little that can be said or written about such a lovely person, who looked forward so eagerly to serving the ladies in this 1986-87 year, that would make it any easier to comprehend. The ladies' activities, of necessity, will continue, but there will always be a void in their organization that will exist as long as memories continue to be memories.

In addition to her husband, National Secretary Herbert A. Butt, Lora is survived by a son, Clayton L. Butt, and a daughter, Mrs. L. Carolyn George, and a sister, Mrs. Virginia Hiskett, as well as four grandchildren.

Funeral services were held from the Peace Lutheran Church in Kansas City with interment in Memorial Park Cemetery on September 18th.

#### President's Report

Funeral services were conducted this morning for National Auxiliary President Lora Butt of Independence, MO. It is 6:30 P.M. September 18th as I pen these shocking words and I have just concluded a lengthy telephone conversation with Natinal Secretary and husband Herb. I believe we were both trying to console each other.

Several hundred friends and relatives attended the services. I am sorry to say that I was not present, but Rainbow was ably represented by a number of people, including Past National Auxiliary President Oriana Grimm and her husband, PNP Hugo Grimm. Also attending were Myrtle Evanoff, immediate PNAP, and her husband, PNP Rube Evanoff.

The four of us, Lora, Herb, my wife and I had completed plans to attend the Texas meeting at the Stubbs' Ranch next week; the Western Reunion in Las Vegas in October and were making the final arrangements to attend the Northeast Reunion in Sturbridge, Massachusetts and the 40th Annual Veterans Day activities in Birmingham in November.

Lora, being the outgoing exhuberant person she was, was really looking forward to doing her part to represent Rainbow, and it is a pity she was not even able to attend her first visitation. I am confident, however, the ladies of the Auxiliary will regroup in short order and, of course, Betty and I intend to carry out every visitation to the best of our ability.

Lora was a charming, loving and witty person, who deeply affected the lives and feelings of all of us who came into close contact with her. Although I had met her years ago, I didn't really get to know her well until several years ago when we were both elected as vice presidents of our respective bodies and working toward the current presidential offices. We join all of you Rainbowers everywhere in extending our heartfelt sympathy and condolences to the Butt family. Farewell, Lora, we will miss you forever.

I received a letter recently from Don Downard, our Service Officer, regarding a clipping which states that all WW II veterans are entitled to a dividend of 65 cents per \$1,000 of their G.I. insurance for each month of service and is due regardless of whether or not the insurance is still carried. Don says this is a hoax, which rears its ugly head about every year and is just not true. He says he has had to deal with many letters annually over the past 20 years, informing veterans that this is a fake, so read and heed fellows: If it sounds too good to be true, it probably is. By the way, fellows, the first of Don's articles regarding veterans affairs arrived in Editor Jim Wright's hands too late to make the September issue, but is pre-

#### MacArthur Memorial

The annual wreath laying ceremony was conducted at the graveside of General Douglas MacArthur at 1100 hours on July 11, 1986. The invocation was given by Reserve Chaplain Army James Lovingood. The wreath was laid by Bill O'Shields. Colonel (Ret) Lyman H. Hammond, Jr., read two articles in memoriam. To the Rainbow veterans he read "Rainbow Farewell" as printed on page 3 of the May issue of the Rainbow Reveille. To all veterans he read the poem by Edward R. Johnson on page 4 of the June issue of the Reveille.

Colonel Hammond reports this is an impressive ceremony and one which the Department of Civic Facilities, City of Norfolk, would like to perpetuate, but that it is becoming increasingly difficult to get any kind of veterans' attendance. He suggests that probably the best procedure is to continue the simple wreath-laying with a special ceremony in significant years, such as in 1988, which will be the seventieth anniversary.

#### New Memorial Sites

The Air Museum in Dayton, Ohio displays a huge Nazi banner with the inscription "Schweinfurt" on it and a letter from General Collins donating it to the Air Corps with the following legend: "We have avenged your death."

The American Legion of Iowa has donated over \$5,000 to the State for refurbishing the painting in the Iowa State Capitol showing the Rainbow Division WW I 168th Infantry in their old glory in Des Moines.

#### Not To Be Sneezed At

Two CompanyA, 242d Infantry veterans attending their first national reunion in Oklahoma City found they had more in common than just being in the same platoon and squad. Meeting for the first time in over 41 years, Myron C. Roberts of Edmond, OK and Glenn E. Schmidt of Sacramento, CA embraced as they shared their WW II experiences and then discovered they had been in the same POW camp and shared the same barracks life in Stalag IXB.

This was not to be the only bond between them as, at the Saturday evening banquet, Myron produced a large handkerchief with eleven names embroidered on it. Much to his surprise, Glenn discovered his name and address on it - a simple act of comradeship long forgotten. Myron's wife had highlighted the names and the addresses in various colored threads and hand stitched a rainbow in each corner. Both men were overcome with emotion as they recounted experiences of cold, sickness and hunger endured during their stay near Bad Orb, Germany. The handkerchief was signed prior to liberation so the men could be traced in the event some became separated or did not return.

Perhaps this chance meeting will result in other contacts and bring together again these "Bad Orb Buddies." The nine other men who signed the handkerchief are: Merle E. 

Changes in VA Laws are being considered and debated on Capitol Hill at this time, due to efforts to reduce the national debt. Some changes have actually been enacted. Mr. Downard will endeavor to keep abreast of these in order to give our readers accurate information.

Many cases involving veterans' benefits and claims have been studied and processed over Don's desk during the more than 20 years he served as a Veterans Service Officer for Disabled American Veterans and Texas Veterans Affairs Commission. Each one is different and requires different action.

Two situations pop up that are really sad: One is there are veterans out there who are entitled to benefits, who don't know it. This is extremely unfortunate, because some of these ex-warriors really need help. Some may think they are entitled to something, but just aren't sure and, therefore, refrain from submitting a claim. The answer to this is: "When in doubt, salute." If you are not entitled, you will be tactfully and politely informed as to the reasons why.

Secondly, Mr. Downard has seen proceeds of GI insurance go to someone the veteran did not intend it for. This includes ex-wives, perhaps divorced years ago; mothers, who are now deceased and, even friends long since lost. Remember that the insurance proceeds will go to the beneficiary or contingent beneficiary you chose perhaps forty years ago. The solution: Keep your beneficiary designation up to date. The insurance does not change when you remarry or want a different person to receive the proceeds. You must notify the VA if you expect your insurance to go to another, other than the original beneficiary.

Another matter, also about insurance, is that most VA life insurance premiums can be waived so that you do not have to pay the premiums if you are totally disabled. We know of many veterans who continued to pay after becoming totally disabled; some even bed ridden.

Your Service Officer will answer any letters received inquiring about possible benefits and he will advise you as to how and where to file any claims, so, if you need help, let him hear form you. Simply

# Smithsonian Honors For Rainbow Veteran

Lt. Col. David Binkley, who died at age 86 in Lemoyne, PA on November 27, 1985, was a highly decorated veteran of both WW I and WW II. In WW I he was a member of the 168th Infantry, 42nd Rainbow Division. He served in the Asiatic and Pacific theaters during WW II.

For his service in the two wars he was the recipient of the Distinguished Service Cross, Italian War Cross, Bronze Star and on three occasions was awarded the Purple Heart.

As a Private in WW I, Binkley sought and obtained permission to go out alone in front of the line to recover his corporal, who was lying severely wounded in the open. He had to cross a 50 yard area swept by enemy machine guns. Needless to say, he rescued his corpral, although himself wounded in the process, but refused to go to the aid station and remained in action until his company had attained its objective.

Because of his heroism, Lt. Col. Binkley was selected to have his portrait painted by artist Joseph C. Chase and his portrait is now displayed at the Smithsonian Institution in Washington, D.C.
