Rainbow Lives In Austria



The January Reveille carried an article on "Rainbow History and the Painting of Rainbow in Numerous Places." The Austrians remember the 42d Division's presence in 1945-46 for many reasons, but a constant reminder has been the rainbows painted on stone. In the 40 years since WW II these have weathered and faded.

President Woelfer is in receipt of a letter through the U.S. Embassy in Vienna from the Bezirkleiter of Pinzgau, Land Salzburg, Austria, stating the Environment and Mountain Watch Department of Pinzgau has had the rainbow painted on the rock face along the main highway leading to Salzburg from Zell Am Zee, near the towns of Unken and Weisbach, repainted to its original colors.

Several pictures accompanied the letter, one of which is shown above, together with a pamphlet titled "The Americans In Pinzgau." The 42d Rainbow Division receives a fair share of coverage. According to the Austrians, the 242 Infantry was in the area. Obviously the Austrians consider us a part of their history. Some of you may have helped paint the rainbows.

President Woelfer has written to the Berzirkleiter (Herr Nikolaus Hinterstoisser) thanking him for his troughtfulness and enclosed a new Rainbow shoulder patch. The photos and pamphlet will be on display at the National Reunion in Oklahoma City.

Best Soldier Award

At the 1984 Reunion the RDVA Memorial Association agreed to sponsor two awards in the 42d Infantry Division: the MacArthur Trophy for the Division Best Unit and the Major General Harry J. Collins Trophy for the Division Best Soldier.

On 22 February 1986 the Division Best Soldier Award was presented by President Carlyle P. Woelfer to Specialist 4 Donna J. Anderson at a ceremony conducted in the armory of the 1st Squadron (Mezd) 101st Calvary, 42d Infantry Division, Staten Island, NY. The presentation was witnessed by RDVA members attending the 1986 Mid-Year in Newark, NY.

The Collins Trophy is a large plaque with a statue of a WW II infantryman, signaling "Follow Me," mounted on it with full sized rainbows in the upper corners.

A plate with two stars identifies the trophy and that it has been presented by the RDVA. It has a series of small plates upon which the winner's name is engraved.

Let's Clear The Air

Some of our readers may think it necessary to wash the editor's typewriter out with soap for allowing it to print the word "linkage," but take it easy on his IBM, as the following explanation compiled from information furnished by Vice President Joe Rosalia may clarify the situation:

- 1. Linkage IS NOT synonymous with membership!
- 2. Our Constitution and Bylaws for the past 67 years have been very precise as to membership eligibility.
- 3. No change to our Constitution or Bylaws has been, is now or will be submitted to alter membership criteria.
- 4. Efforts to establish a linkage program between RDVA and the 42d Infantry (Rainbow) Division, NYARNG, are officially sanctioned actions of RDVA through appropriate conduct of our duly elected national officers.
- 5. At the 1984 mid-year executive meeting in Orlando, FL, the national President appointed a committee to conduct a feasibility study on Linkage.
- 6. The Linkage Committee's report was given to the executive board in 1984 at Windsor, Ontario. The report was accepted and subsequently the findings and recommendations were presented to the membership for consideration.
- 7. The membership, at its first business meeting in Windsor, approved for adoption the implementation of the program of Linkage as presented. There were no dissenting votes.
- 8. The Memorial Foundation, in open session, approved and allocated funds to support the awards, etc.

This is a brief outline of what has transpired to date. The first of the authorized awards was presented by President Carlyle P. Woelfer on February 22 during the '86 mid-year. (See "Best Soldier Award" on page one.)

Again, no change contemplated in membership requirements.

"Best Private"

Rainbow Veteran Robert R. Monsen would like to find the men known as "Best Private" from other units, who were sent to Camp Gruber to help start the 42d Infantry Rainbow Division in World War II. Each Cadreman of the Rainbow Division was assigned to the equivalent platoon, company, etc., of the 102d Infantry Division in January 1943. From the 45 Infantry Companies of the 102d Division the "Best Privates" were chosen. In April 1943 the Rainbow Cadre and "Best Privates" boarded trucks and headed north from Camp Maxey, Texas to Camp Gruber, Oklahoma. The "Best Privates" were initially assigned to Division Headquarters Company or returned to an equivalent unit. Robert Monsen elected to transfer to Company I, 222d Infantry Regiment.

The large trophy will be displayed in an appropriate area. Spec 4 Anderson received a smaller replica of the Collins Trophy, a \$100 US Savings Bond, a pocket patch for the field uniform embroidered "Division Best Soldier-1985" with a subdued rainbow, plus Rainbow Ribbons for the Class "A" uniform epaulets. Her company received a streamer for the company guidon reading "Division Best Soldier — 1985" with rainbows at each end of the streamer.

The command sergeant majors of each battalion and brigade level of the Division selected the winner from candidates proposed by each of the major subordinate commands, each of whom was first chosen from their company and battalion.

The Reveille Committee is contemplating a feasibility study on changing the publication schedule of the Reveille to give better coverage to the mid-year meetings so it will not be ancient history by the time you read about it. A decision should be forthcoming at Oklahoma City.

What Do You Remember Of World War I?


The BBC (British Broadcasting Corp.) is making a documentary and would be very pleased to hear from Americans who have any memories of this period.



Hatten - Rittershoffen Monument

On June 16, 1985 at Hatten and Rittershoffen, France, a ceremony was held commemorating the fortieth Anniversary of the WW II battle of the area which lasted from January through March, 1945.

For their heroic defense of this sector members of the 1st Bn 242d were awarded the Presidential Citation.

The activities began with an ecumenical service in the local Catholic church in Hatten conducted jointly by Lutheran and Catholic clergy. In addition, impressive addresses were given by the Mayor of Hatten and other dignitaries. In attendance were American, French and German veterans who had participated in that battle, one in a wheelchair and others who had lost an arm or leg.

Upon departing the church those attending marched midway to Rittershoffen for the unveiling of a monument dedicated to the battle. Already assembled were active duty American and French troops and a military band. Each nation had its own spokesman who spoke in his native tongue, after which each speech was translated into English.

Wear Them Proudly

The Army encourages wartime service veterans and retirees to wear their authorized military awards and decorations on Memorial Day, Armed Forces Day, Fourth of July and Veterans' Day, as well as military funerals, memorial services and military weddings. These awards and decorations may be worn on civilian clothing during such events in the issued size or in miniature.

The wearing of awards and decorations on the occasions cited is considered to be evidence of pride in service to our country and identification with and respect for departed veterans and armed forces personnel when attending military funerals and memorial services. Military retirees may also wear uniforms appropriate for such occasions and for special military events.

Additional Honors For Task Force Linden Vets

Were you a veteran of Task Force Linden? If so, the following information may be of special interest to you:

In 1947 the Department of the Army changed the identification of the Ardennes Campaign to Ardennes-Alsace. This campaign now covers the period from about 11 December 1944 to 26 January 1945. It includes, in addition to Belgium, the Department of Alsace France, including the fighting in that area in January and the units engaged in that area. Task Force Linden's operations in that area are covered in that campaign.

If you were a member of Task Force Linden and participated in the January action to January 26 or were evacuated, wounded or sick or were captured while in that combat, you are authorized to take credit for that campaign.

Since most Rainbow soldiers left the service prior to 1947, your records may show only Rhineland and Central Europe Campaigns as the 42d Infantry Division was inactivated in Austria in July 1946. Campaign credit for Central Europe ended with VE Day. With credit added for the three campaigns, i.e., Alsace-Ardennes, Rhineland and Central Europe, a veteran may wear three battle stars on the ETO Ribbon. Your records can be corrected, if interested, through the normal channels to add the campaign credit.

At the conclusion of the speeches the monument was unveiled and three wreaths placed at its base, one each from the Americans, French and Germans.

The monument is of solid stone with the inscription in French, in remembrance of the hardships encountered by the people of these three nations who were in the area during the conflict.

A parade was then formed with the dignitaries leading the way, followed by the French and American troops. The American veterans followed the troops and marched back to Hatten. Residents of the area lined both sides of the streets, waving from windows, many with tears in their eyes. It was apparent the event brought back many unpleasant memories. The parade ended at the museum where a German tank was placed in the courtyard.

The museum is fantastic. It houses every conceivable memento of war: mortar fins, rifles, uniforms of both sides, army signs, photographs taken during WW II and should be included in your itinerary if you travel in Europe.

There were many more activities, including a luncheon, visits between the Americans and Germans, swapping of war stories on both sides.

In addition to Rainbow veterans, there were 24 from the 14th Armored and several from the 79th Division.

"Looking back at our meeting at Hatten on June 16, 1985 I must say it was deeply (continued in column 3)

moving to find that we, as former enemies, were able to join together again as friends in peace, willing to forgive one another and all this among the very people who suffered severely from our military operation 40 years ago. What a gesture of generosity and understanding from those who asked us to meet on their homeground! I wish that the people of Hatten and Rittershoffen, in what they did for us, could give an example to others. Let us hope for peace in the future, for freedom and reconciliation. And let us remain as friends."

pected to use all available means to implement and support membership approved actions. As is my duty, I will continue to do so in all areas, to include the linkage actions.

For the RDVA to withdraw unilaterally from a written agreement, made in good faith with the Commanding General, 42d Infantry (Rainbow) Division, NYARNG, would be the same as going back on our word. Such a breach of faith would be very damaging to the good name of Rainbow veterans and not understood by Division members. There is no apparent benefit to be derived for anyone from such action, but much harm is evident. Let us refrain from further bickering and uninformed claims on this subject and cease and desist from such considerations.
