777 BEAT THE ODDS MAKE OKLAHOMA CITY A WINNER

The odds? An Oklahoma heat wave with the thermometer reaching 97 every day and, while not a record was a darn good average. Ice machines that paid off with about as much regularity as a Las Vegas slot machine. An early morning thunderstorm on Friday, July 11th, that backed up sewers and forced a number of Rainbowers to move from the "500" building. A malfunctioning fire alarm that sounded outside the room of newly elected President Fred Goldsmith at 4:30 A.M. Saturday, July 12th. Finally, a water main break just north of I-40 and two blocks from the hotel, causing the water to be shut off in the main building at 1:00 P.M., threatening to curtail or even cancel Saturday night's banquet. We understand it came back on in the wee hours of Sunday morning, allowing all the Rainbowers housed in that section of the complex to make a clean break for home.

But, first things first. All those people in the dining room and waiting to be seated Wednesday evening were treated to an

Wednesday evening were treated to an excellent performance by a mime-magician, who visited many of the tables in the dining room and performed his various tricks of magic. There is still some doubt about the lace handkerchief he pulled from Colonel Carlyle Woelfer's pocket.

After dinner all one had to do was take a peek into the room where the "Early Bird" party was in progress and see that a near record crowd was in attendance.

The joint meeting and general session the afternoon of July 10th were well attended.

The Reinberg Dange held in the hellmoon the right of July 10th were well attended.

The Rainbow Dance held in the ballroom the night of July 10th was packed, with the orchestra playing those golden oldies that you could tap your foot to and not go deaf in the process.

Another general session the morning of July 11th with a capacity crowd on hand, including approximately 49 (no actual count available) Rainbow veterans who were attending their first reunion.

The Rainbow luncheon was held at noon that same day, with welcoming remarks by Vice Mayor I. G. Purser of Oklahoma City. A brief ceremony was held, honoring Staff Sergeant Adolfo B. Morales in absentia (Co. K, 222d Infantry) with former Tech Sergeant Sam Platamone acting as surrogate as President Carlyle Woelfer presented the bronze star with an oak leaf cluster; and combat infantryman badge. Sergeant Morales suffered the loss of an arm; had 32 additional bullet wounds as he protected his buddies in a withdrawal at Moder River. A visit or card from former K Company, 222d Infantry members or any other Rainbower would be a nice gesture. His address is 4111 West 102d, Inglewood, CA 90304.

RDVA's Annual Memorial Service was held immediately following the luncheon, led by National Chaplain Rev. Mr. James W. Dunham, with his beautiful "reflections,"

PRESIDENT'S MESSAGE



Well, the 67th Annual Reunion of the National Association Rainbow Division Veterans is now history. With 777 people attending in Oklahoma City it was one of the largest and best, thanks to Mary and Al Brewer and their Chapter. They went "all out" and we want them to know their efforts were deeply appreciated.

I have never aspired to be a national president and was full of misgivings when I accepted the office of President Elect at the reunion in West Palm Beach, Florida a year ago. Now I'm glad that I went ahead, in spite of my doubts, and in the past year have come up with a number of ideas that have been discussed with others and now hope to implement this year.

A committee of five will be appointed to review our Constitution and bylaws to determine if it should be updated and/or rewritten and retyped, with copies distributed to all chapter secretaries.

The same committee will be asked to review our business meetings format for the reunions and determine if we can get by with one less business session and thereby have more leisure time to attend a local tour or function at future reunions. This committee will be asked to make a preliminary report at the forthcoming mid-year meeting to be held in Phoenix, Arizona in February 1987.

I want to encourage more input to the Reveille as I am confident each of you have stories of your wartime experiences to tell, if you would only take time to put them down on paper.

At the Oklahoma City Reunion it was suggested the Reveille be reduced from six to four issues per year because the Editor was not receiving enough material, photos, etc., to sustain six editions per year. This suggestion was voted down by the membership and the Budget Committee and the membership approved extra funds to continue the publication of six issues. I have requested assistance of the officers and the National Historian, as well as an ex P.O.W. and a holder of the Unit Citation, in providing good material in hopes it will cause each of you to contri-

REPORT OF CONSTITUTION AND BYLAWS COMMITTEE

The Constitution and Bylaws Committee met at 10:30 AM, July 12, 1986, with 12 members and the Chairman present. The following items were discussed and, where action by the Reunion was requested, the required action was asked for as each item was presented.

- 1. We propose to add to Article 4, Section 13, which provides for the Memorials Officer, the following sentence:
- "The Executive Committee will also appoint an Assistant Memorials Officer."
- 2. In Article 3, Section 6, we propose to delete from the first sentence the words "exclusively" and "of a unit."
- 3. We propose that the original Preamble to the Constitution be adopted as the Preamble to the present Constitution and Bylaws as follows:
- "We, the members of the 42nd Infantry Rainbow Division of World War I and World War II, in order to perpetuate that spirit of comradeship, which was the greatest single factor in the success of the Division, and to keep alive the memory of our departed comrades, do ordain and establish this Constitution for the Veterans of the 42nd Infantry Rainbow Division."
- 4. We propose to accept the July 1987 Reunion dates, to fulfill the mandate to consider the update of the RDVA Constitution and Bylaws. We recommend that the incoming President appoint a committee, consisting of five members, to review a draft of a revision of the Constitution and Bylaws presented to the Committee on this date. We propose that copies of the draft of the proposed revised C & BL and the present updated C & BL be placed in the hands of the Officers of the Association and all Chapter Presidents to review and respond to the draft to the Committee by November 1, 1986 and such responses included in a Committee review to be held prior to the Mid-Year Reunion in February 1987 for presentation fo the Committee's draft to the Executive Committee at that session for review.
- 5. The C & BL Committee was asked to consider the implications, if any, of the "linkage" proposal that was voted on at Windsor. It was further asked to consider whether that vote violated any provisions of the C & BL. The Committee unanimously agreed as follows:
- a. Nothing in the C & BL will allow membership or associate membership for any person, except those veterans of WW I and WW II who served in the Rainbow Division during the dates listed in the C & BL and their "sons, etc."

- b. Because of the specific requirements in the C & BL for membership, the Committee agreed unanimously that the word "linkage" be forthwith abandoned by the Association because this has led to a misunderstanding on the part of the members of the Association and could lead to a misunderstanding on the part of the members of the existing Rainbow Division.
- c. The Committee reviewed the "Draft Linkage Proposal" between RDVA and the 42nd Infantry (Rainbow) Division. The Committee agrees unanimously that the vote on that proposal was technically done in accordance with proper rules of order. However, it was approved without full understanding of the issues and without a sufficient forewarning of its contents. It further has created a detrimental divisiveness in this Association that must be addressed. Accordingly, the Committee unanimously proposes that that draft proposal be amended to include only the following items:

Item 1. Except delete "formal" and it will now read: "Establish and maintain active communication between the Division and the RDVA to provide for a free flow of information in an effort to develop common interests."

Item 3. "Develop and initiate an awards program in coordination with the Division, to be sponsored by the RDVA, that would recognized outstanding individuals and units of the Division. Such awards could honor famous individuals of the past that identify with the Division, such as General Douglas MacArthur, Secretary of the Army Wilbur Brucker (1st Lt. WW I) and Major General Harry J. Collins."

No other provisions of the draft shall be activated without future specific approval of this Association in Reunion assembled.

Those deleted from the draft proposal are as follows:

Item 2. "The Division will inform the RDVA regarding activities and events that will contribute to the development of support and pride in the Division by the RDVA. A vehicle for such dissemination could be provision of a column in the Rainbow Reveille for use by the Division."

Item 4. "RDVA to offer assistance in further development of the Division Museum with contributions, information, artifacts, historical data with meaning to the Division's history and traditions."

Item 5. "Provide for invitations to RDVA officers to participate in activities with significance to both the veterans and the Division's Organization Day, Division Reviews, etc."

d. Nothing in this report shall be interpreted to be a denial of the RDVA time honored support of the men and women now serving in the U.S. Armed Forces, including present 42nd Infantry Rainbow Division and, further, the Committee recommends that the Association move forward in its purpose of comradeship in perpetuating the memory of the men who served Rainbow and its causes in two World Wars.

RAINBOW SCHOLARSHIP PROGRAM

As reported in the May issue of Reveille the Rainbow Scholarship Program of the Memorial Foundation, which was voted on at Windsor in 1984, had its first year of operation during 1985-86. In the first year it awarded two scholarships, which will be reported on in the November issue of Reveille. At the Oklahoma City Reunion the Scholarship Committee awarded six scholarships for 1986-87. Those named as Rainbow Scholars were William Clayton, Jr. in Graphic Design at California State University, Chico; Mayland Crosson in Business and Psychology at Pennsylvania State University; Donald M. Downard in Engineering at Embry-Riddle Aeronautical University in Arizona; Tammy Manuel in Veterinary Medicine at the University of Nevada, Reno; Morgan Ray-Mulholland in Psychology at Sierra University, California; and Arlene Kemmerer Slater in Nursing at Slippery Rock State University in Pennsylvania. Their work includes communication, ecology, natural resources, justice, social services, critical analysis, teaching and government.

These young people will be acting as our "scouts" in our continuing exploration and engagement to help create a more peaceful world of understanding and brotherhood — that Rainbow Vision. Each of these Rainbow Scholars will explore his/her areas of study and research and report on what has been learned that might help create a better world that will keep the Spirit of Rainbow living and growing.

Significantly, this Rainbow Scholarship Program, in the words of our Preamble. will "perpetuate and honor the spirit of comradeship of RDVA WW I and WW II members and keep alive the memory of our departed comrades." It will also mean that all of our supreme efforts and sacrifices in those conflicts will not have been in vain as our sponsored young people continue that noble search for freedom from war begun by us so long ago.

To support the scholarships we naturally need funds. Significant contributions have been recently received from Kurt Fredrick and Mrs. Walter Wetle. Appreciative recognition was given for these gifts at the Oklahoma City meeting. Kurt Fredrick donated \$1,000 to the Rainbow Scholarship Fund. As a WW I veteran he is showing us the way. With his gift he sent a most poignant poem:

"When the last roll call shall have sounded

When hatred shall have come to an end Then will the Rainbow of Peace Everlasting

Over this world extend"

Mrs. Walter Wetle gave \$2,000 to the Rainbow Scholarship Fund in remembrance of her son, Corporal Walter Wetle of Battery B, 232nd Field Artillery, who was killed in action in Germany in April 1945. Bob Jecklin and a number of other Battery B members, who knew Corporal Wetle and who were with him at the time his jeep was shelled, were present at Oklahoma City to witness this very important gift by Mrs. Wetle in honor of her son. This is the kind of commitment that can "remember the dead and remind the living." The action by Mrs. Wetle and Kurt Fredrick will go a long way toward keeping Rainbow an important force in the world.

There will be a report in the November Reveille on the status of the scholarship fund and contributions to date. Scholarship application forms and forms for contributions will be included in that issue.



RAINBOW GIRL




A Rainbow Reunion would not be the same without the presence of the one and only Rainbow Girl, Peggy Fleming, who again attended the reunion in Oklahoma City.
