MILE HIGH DENVER ATTAINS NEW HEIGHTS - 1001 IN ATTENDANCE

Despite continuing media reports of heat and drought throughout the Country and particularly in the midwest, Rainbow veterans and wives, Auxiliary members and guests set a "modern" attendance record at the 69th Annual National Reunion of the 42nd Infantry Rainbow Division Veterans Association at the Sheraton Tech Center in Denver on July 13, 14, 15 & 16, when 1001 people actually registered and were present, despite last minute cancellations of a number who had pre-registered, due to various and sundry reasons.

(ED'S NOTE: If you drove to Denver from the east and came in on I-70, we are sorry we didn't know it was more than 100 miles to the one and only rest stop between Kansas and Denver. Not even a tree; nothing but wheat as far as the eye could see.)

Heading the list of those present were 14 World War I Rainbow veterans, three of whom were accompanied by their wives; i.e., Mrs. George Irwin, Mrs. William Hamm and Mrs. Horace Rose. There were also eight widows of WW I Rainbowers present. In addition, sixteen of eighteen Past National Presidents attended. Only Charles B. Sayers, Jr., (1974-1975) and Johnnie Stubbs (1975-1976) were unable to attend. A large number of people attending their first national reunion helped balloon the attendance.

In customary fashion, the Early Bird Party the evening of July 13th got the festivities under way and what a kick-off it was. Dr. George Lynn, musician, conductor and composer, who conducted the Rainbow Chorus at Camp Gruber in 1944, played and led the early birds in singing some of those memorable Rainbow songs. Afterward a professional performer from the Colorado Springs area played golden oldies throughout the remainder of the evening. This gentleman donated his services. Unfortunately his name is unavailable, but we are certain Reunion Chairman Dick Bayles will have conveyed the gratitude of RDVA.

On July 14th the opening joint session was addressed by Colorado Lieutenant Governor Michael Callahan, who welcomed the group to Denver, after which the El Jebel Temple Pipe Band played and performed (bagpipes to the uninitiated).

The evening of the 14th was given over to the traditional dance and, as usual, the dance floor was a crowded place.

During the early bird party the hotel, in lieu of the daily free cocktails, provided a free open bar for two hours $-8:00~\mathrm{PM}$ - $10:00~\mathrm{PM}$.

At 10:00 AM Friday, July 15th, the Joint Memorial Service and Champagne Hour were held. (See Memorial Service, Column 1, Page 3). The memorial service was followed immediately by the luncheon with approximately half of those present rushing away to board the sight-seeing busses for the tour of the Air Force Academy and Garden of the Gods. In all, there were ten busses, each holding 45 passengers.

Interspersed throughout the four days were unit meetings, committee meetings, business sessions of both the RDVA and Auxiliary, all leading up to the Grand finale on Saturday evening, July 16th. The banquet proved to be a huge success with delicious food. (Entree: filet plus breast of chicken) The service was superb.

Ted Simonson served as Emcee. There were the customary introductions of honored guests, newly elected officers of both RDVA and the Auxiliary; the surrender of the gavel by outgoing President Dee Eberhart to incoming President John M. (Jack) Keyser; the transfer of the Red Cap's hat to Arlie Woods, who is also the newly elected President of the Artillery Chapter, so he can accompany wife Catharine, the 1988-89 Auxiliary President.

The President's Reception was the last official function and capped off a very successful reunion, after which many people were rushing to their rooms to grab a short night's rest before catching those early morning flights and heading back home.

The hotel amenities were everything they had advertised; and a courteous and efficient staff were always available. It was a smoothly run reunion and congratulations go to Reunion Chairman Dick Bayles and his Committee and other volunteers.

To sum it all up, one lady, who attended her first reunion, reported she had "tired ears." We think it was worth the effort to be there. If you didn't make it, you can be sure your buddies were thinking of you.

MEMORIAL SERVICE

A capacity audience gathered in the Empire Ballroom of the Sheraton Denver Tech Center for the 10:00 A.M. RDVA Memorial Service paying tribute to not only 45 WW I veternas and 80 WW II veterans, who passed over the Rainbow in the past year, but to auxiliary members who have died, as well as to those comrades who did not return from both WW I and WW II and to those valiant men who have passed over the Rainbow in the intervening years since the conclusion of hostilities.

National Chaplain Rev. Raymond H. Willemssen gave the invocation, followed by scripture reading by Associate Chaplain Fr. Robert F. Weiss, which was in turn followed by a moment of silent prayer for our departed comrades.

Soloist Allison Twiss-O'Neill, daughter of Rainbower Bill Twiss, led the audience in singing "HOW GREAT THOU ART" and it never sounded better or more meaningful. Rainbower Dr. George A. Lynn was the accompanist during all of the musical numbers on the program, which subsequently included "AMERICA THE BEAUTIFUL" and a solo rendition by Allison Twiss-O'Neill of the last stanza of the Star Spangled Banner.

Rev. Willemssen offered "Reflections" during the service, which included the playing of a recording from the 1939 Rainbow Division Veterans Reunion with excerpts from other Rainbow affairs. The fidelity of the recording from circa 1939 was unbelievable, a tribute to today's electronic experts.

The memorial service, itself, was concluded with a prayer and followed immediately by the Champagne Hour narrated by Theodore A. Johnson, as only he, with his resonant baritone voice, can do.

The entire program concluded with a sounding of "Taps" with an echo effect from different areas of the ballroom.

It is doubtful if there was a dry eye among those present at this very meaningful and moving service.

BEST SOLDIER AWARD

For the third time a soldier from the 242nd Signal Battalion (Company B) was selected as the 42nd Infantry Rainbow Division best soldier for the training year 1987. The presentation of the Major General Harry J. Collins award was made in June, 1988, during a 242nd Signal Battalion formation at Fort Drum, NY by BG Evans, Division Commander. The recipient of the award

was SPC Seymour Lichtenstein.

The award consists of a plaque, a \$100 U.S. Savings Bond, a pocket patch for his field clothing identifying him as "Division Best Soldier - 1987," plus a pair of Rainbow ribbons to be worn on his Class A uniform.

A larger rotating plaque between units has the name of the best soldier engraved on it for each year.

CHAPTER CHATTER

Although most 392nd FA BN veterans are members of the Artillery Chapter, John P. Igoe, President, Philadelphia Chapter, reports the 392nd held its first get-together since WW II at the RDVA Reunion in Denver.

According to Jack Igoe, time seemed to pale and disappear as friendships were renewed in the 392nd Hospitality Suite. Preparations for the reunion were in the making 18 months prior to Denver and, of 102 former comrades contacted, 33 attended — most with their wives. Three, who planned to attend, had to cancel due to health problems. Plans are already under way to meet again in St. Louis in 1989.

On May 29, 1988, the Michigan State Chapter held memorial services at historic Fort Wayne, with complete cooperation from Dr. William P. Phenix of the Detroit Historical Museum. The service was conducted by Chaplain Arlie Woods. There were 40 people present; members, wives, auxiliary and guests. An honor guard was supplied by the U.S. Naval Sea Cadets, plus representatives from the Historical Society of Fort Wayne. Three were dressed in Civil War uniforms and one in a Spanish American War uniform.

Excellent public relations were established through President Al Joerin and Dr. Phenix with TV coverage by Channels 2 and 4, which aired at 11:00 PM and 6:00 PM respectively. The Detroit News interviewed one WW I Veteran, Lavell Smith, of the 167th MG Unit; Chester Dzikowski of Battery A 542nd F.A., along with Marty Pawlak, all outdoors at the foot of the Detroit River.

After all the pomp and ceremonies the RDVA people assembled for a luncheon, followed by a business meeting and the election of officers for the ensuing year.

Headquarters & Headquarters Battery, Division Artillery, had eleven members present at Denver, compared to a high mark of four in previous years, thanks to splendid work by Reunion Chairman Dick Bayles.

KEEPING IN TOUCH

REAL PEOPLE: Skip Stevenson narrates the sound track from the 1984 TV program covering the dedication of the Muskogee Memorial SOUNDS OF REUNION: Candid recordings that capture the excitement of national reunions. MY BUDDY: Rainbow's Poet Laureate Kurt Fredrick recites a tribute to comrades-in-arms in this recording of his well known poem. FOXHOLE RELIGION: The Rainbow story in song/verse presented to the drummer's cadence by Bill Clayton, followed by a reading of his essay RAINBOW BOND. MUSIC REMEMBERED.

SIDE B PROGRAM: The Champagne Hour, recorded in 1939 in the style of the golden years of radio. A dramatic presentation of the famous Rainbow Victory in World War I, brought up to date with PNP Ted Johnson's narration of RAINBOW IN WORLD WAR II. Rainbow veterans have observed the traditional celebration of the Champagne Hour since RDVA was founded in 1919. ALL IS QUIET: A moving tribute to a Rainbow veteran who served during the Great War by RDVA Associate Member Clark Jarrett. ON OR ABOUT 6-30-1918

Gary G. Grant, Company C, 117th FSB, in WW I writes: "Having route marched from Vitrey la Ville with a rest stop in Chalons, where the beer in the cafes was warm and flat, we arrived in a small town called La Cheppe. In no time the Alabamians in the unit discovered that every wine cellar in the area was full of cases of champagne that had been moved back out of Rheims to avoid possible cap-

ture during the anticipated German offensive.

The Rainbow soldiers had just been paid; francs were exchanging twenty for a dollar and the householders were willing to sell for as little as half a franc a bottle. What followed must have been the greatest binge in history. Other small towns in the area must have had the same experience. By the second day all the cellars were empty.

MEDICAL RECORDS LOCATED

The National Archives and Records Administration, on June 15, advised the VA it had located a collection of computer tapes containing some 10 million army medical records that partially fill a gap created when a 1973 fire destroyed millions of military files at the military records center in St. Louis. The newly found records cover the years from 1942 to 1945 and from 1950 to 1954.

For certain veterans, whose claims for disability compensation were denied since the fire, the VA may now be able to establish documentary evidence to support their claims. To speed these claims, the VA has introduced special procedures, collectively called Project Expedite, which involves massive cross-checking of files to determine cases that can be reopened. VA benefits counselors now hope to assist many veterans whose claims had been denied because no record was available to confirm medical disabilities that occurred during military service.

The newly found medical records were provided to the National Archives by the National Research Council, a private organization that had been engaged in analysis of Army hospital records in the 1950's. The computerized information relfects battle injuries treated in army hospitals and a sample of hospitalizations for other reasons. The records cover personnel who served in the Army and Army Air Corps.

Veterans and survivors, unsure whether their disability compensation claims are affected, should contact the nearest VA Reginal Office. A toll free number of the nearest VA Regional Office is listed in the Federal Government section of telephone directories. In New York the number is 1-800-442-5882.
