EDITOR'S COLUMN

Larry Nagel, H2B, 232nd Inf., writes: I can agree with your comments regarding Charles Whiting's book on "Nordwind." I read another of his books, "48 Hours to Hamelburg." It was also filled with inaccuracies as to time, place and sequence of events. The book was about Gen. Patton's attempt to liberate Hamelburg POW camp, where I was a "guest" at the time. I wrote to him trying to correct his statements, but never received a response. The most glaring error was a statement that the attack on the camp took place in the dark. This couldn't be, as I recall distinctly, standing and watching evacuation of the townspeople very clearly — a distance of some 1500 yards.

Old foxhole buddy, Ted Johnson, passes on the following information. In the Constitution for the Memorial Foundation, the provision now is that children of Rainbow must be represented on the Board of Trustees in perpetuity. This means that the Board could be composed entirely of progeny of Rainbow, either male or female.

Ted believes, and your editor concurs, that until recently there has been very little interest shown by the children of our generation. Now, however, there seems to be a groundswell of inquiries building, betokening a great thirst for knowledge. This is evidenced by letters and phone calls, on the part of children and grandchildren, seeking details on their forebears participation in WWII.

He feels that the time is ripe to actively promote the enlistment of our children's continuing search of their "roots." At this time, there are several erudite Rainbowers hard at work endeavoring to gather as many oral histories as they can. This is in order to preserve our history as it truly was, and not as some revisionist would have it. (Editor's note): A case in point is Dick Engler's book, "The Final Crisis" and Mme. Lise Pommois' account of the Moder River

Rainbow Scholarship Program Update

The Rainbow Scholarship Program has been in effect since 1985-86. As part of the RDVMF, which, itself was established in 1971.

The Scholarship Program was established at the urging and request of many Rainbow veterans and Auxiliary members who said they wanted a LIVING MEMORIAL to support that Rainbow Vision, of peace, understanding, and brotherhood in a better world for our sons, daughters, and grandsons and granddaughters.

These early supporters envisioned honoring and supporting our young people as RAINBOW SCHOLARS who would go forth in their studies and education to seek out and connect with those issues, problems, and healings in the world. They would, in every sense of the word be Rainbow's "front line troops" working and studying for a better world in our time, just as we did in WWI and WW II.

A LIVING MEMORIAL is just that, a living INVESTMENT in, belief in, and commitment toward our young people as they actively participate in the healing of a troubled world.

A good INVESTMENT returns dividends as it grows and becomes stronger. These investment returns and dividends come through MAKING-RAINBOW-LIVE through the activities and studies of our own young people. What better risk than to bet on and invest in our young people who will create our future.

From its inception, the Scholarship Program has been entirely self-sustaining through contributions received.

It has taken in over \$40,000, since 1985-86. It has disbursed over \$30,000 to 52 Rainbow Scholars in colleges and universities across the country.

Every dollar of income and disbursement has been reported in the BADGE and REVEILLE. No disbursements have been made without the approval of a blue-ribbon committee of Rainbowers.

From two Rainbow Scholars in 1985-86, the program increased to ten new Rainbow scholars by 1988-89. The Scholarship Committee has envisioned a program of about ten new Rainbow Scholars a year as a realistic sustainable program based on past applications and contributions.

At the present increase in reserve funds, the Rainbow Scholarship Program could be self-sustaining by interest alone by 2010, when the RDVA is scheduled to be dissolved.

A Trip Of Remembrance (Conclusion)

My wife and I visited about half of the graves of the 222nd Infantry who were in this cemetery. In walking around it was very apparent that those in the Infantry in WW II had paid a terrible price. We also visited the chapel, and saw a mosaic map of the European campaign. Also, we visited the Wall of Honor which listed the names of personnel whose bodies were never identified. On this wall were several from the 42nd. This visit was sobering to both my wife and me. I realized that I might very well have been there. We then left Epinal and headed north to visit Lorraine Cemetery, located at St. Avold. Our route took us through Luneville, and just north of it found the town I had previously been unable to locate. It was Einville, and was where we had stayed in February. After driving through Einville several times, we continued north toward St. Avold. That next morning we visited Lorraine Cemetery which was very similar to Epinal, except that it contained twice as many graves. We again visited graves of 222nd men, and were again impressed with the terrible price paid by the Infantry.

We spent three weeks on this trip of remembrance. I took 200 slides of the towns and sites described in this article, and have shown them to my family, many friends, and the Colorado chapter of the RDVA.

I would now like to reflect on this trip, and give you my thoughts. When many of my friends heard that I had made this trip, their comment would be, "Why would anyone want to make such a trip?" My answer was always that I wanted to go back and really see this area at a little more leisurely pace where so much happened to me in such a short span of time. However, I'm not sure this covers the reasons. I had a great desire to show my wife these various locations, and show her what actually happened in each of them. Other reasons may have been to show, by way of the slides, how the combat infantryman lived under the conditions of WWII. The lasting memories we are left with are those of the two cemeteries. There it was vividly portrayed the cost of this war and the sacrifice that some of our youth made in order that we might have the freedom we enjoy today.

Now, in retrospect, I feel that I accomplished what I desired to do, and feel more at peace with myself. However, the memories of the two cemeteries will always be with me.

A Case of Mistaken Identity?

People in my own company had me so mad about this that I stopped talking about it. I was written up for the Silver Star, but never got it. It is just as well, as I would not recognize the action described. Here is an account of the action I was in.

On the first day we moved into Hatten, my platoon was placed to the right of the company front. The bazooka man happened to be with me as I was leaving the C.P. We were part way to the next farmhouse, when German tanks swept in. One came up to the house we had just left. When we saw the tank coming, we ducked into a cellar hole, unseen by the tanker, which stopped broadside to us. It was close, maybe 50 yards, but the shot was a nightmare. There was a rise in the ground and a number of apple trees in the way. The bazooka man (unknown to me) had a lot of talk from me as I loaded a round, telling him to clear the mound, keep out of the trees - and of course to hit the tank.

His first shot bounced off the turret, not exploding. The second glanced off the turret, again not exploding. He got the third round on target. It hit the tank between the treads and the wheels. One man came out and was captured. At this point, the other tanks began to pull out, and we left our cover to try to get one. We changed our minds as both 88 and 105 rounds came in.

The story got around that I had fired the bazooka that got the tank. One guy even told me he had loaded the bazooka for me! This issue was resolved a few years back at a reunion. I was told to own up to my actions. I turned to Jim Burns, next to me, and said how mad I was. Jim said, "That was me." Jim came to the company that day, is my build, also wears glasses, and seen behind the bazooka, was mistaken for me.

Our action was very calm. We were not seen by the tank, although they started to swing the turret after the second shot, according to eyewitnesses. Jim and the men in his area were in a real fight at the entrance to town, later caught in a pincers move. Neither of us got an award, but came home. That is enough for us.

Shootout In Sessenheim

John McGovern - COB - 232nd Inf.

James Archey shared a bunk with me in Stalag X1B and was an ideal bunkmate. He had many stories about his life in St. Louis that helped us pass the long days and nights in captivity and he didn't object too strongly to the incessant night turnings that kept one side from getting too sore on the boards we slept on.

James' father was head of homicide in the St. Louis police department for many years, so James was not entirely new to violence. However, I don't think that any of the bad guys in St. Louis had $3\frac{1}{2}$ inch guns.

James Archey was part of a group that moved back from Dengolsheim when that town was attacked in force by the Germans. They stopped in a house on the edge of Sessenheim, which was on the street from Dengolsheim.

I was with an anti-tank crew about two houses, or fifty yards, from the same street, but on the opposite side. Two German tanks came into my view in the gap between the houses and stopped when the first tank was hit by a bazooka round. Almost immediately, the second tank fired its 88 mm. gun.

Archey had stayed on the first floor of the house, while the rest of the men went upstairs. He fired his bazooka at the front of the tank which was coming almost directly toward him, and was less than forty yards away. After he fired, he leaned to the side to reload, just a fraction of a second before the 88 mm. round came through the window and blew out the wall and stairway behind him.

There was a big cloud of plaster dust and the men upstairs jumped and tumbled to the first floor, thinking that Archey had been killed. However, he was able to follow them out the side of the house and catch up with them. The tanks retreated to Dengolsheim.

Bazooka, Bazooka, Who Wants The Bazooka?

After the Rainbow division had captured Wurzburg, the men of the 3rd Platoon of Company "I," Third battalion, 232nd Infantry Regiment, headed north towards a little village by the name of Versbach. We were on the high ground north of Wurzburg and started down the side of this hill, running, tripping, falling and rolling (it was rather steep as I remember) because we were being blasted with German 20mm ack ack guns.


It was on this hill that Pfc. Joseph Nowaki, took a round right on his knee while his ammo bearer Pfc. Harold Lloyd was removing his raincoat from his combat pack. Lloyd immediately called for our aid man Pfc. Walter Hayman to give emergency care to Nowaki.

Lt. John Chuk saw what happened and came immediately to where we were, picked up the bazooka and said in a loud voice "who wants to be the new bazooka man? I happened to be the nearest one in sight and he said, "Machado you're the new bazooka man." I didn't want it but he insisted that I take it, and I did.

Pfc. Harold Lloyd became my ammo bearer, and the two of us manned the bazooka.

I remember firing at a few church steeples and some rounds at houses on the outskirts of villages, but to be very honest with you those pointed nose 2.76 inch bazooka rounds didn't go off on impact as they should. We received the round nose projectiles just about a week before the war ended. We never did fire one of them, but were told that even if it was a ricochet, they would go off.

So much for bazooka, bazooka, who wants the bazooka.

The three purposes of the Foundation are outlined in the revised Constitution and Bylaws presented by Judge Advocate Ted Johnson. These purposes and the Trustee's efforts to advance them follows:

Purpose a. Honor, memorialize, perpetuate, publicize, and instill now and in future generations the valor, heroism and patriotism, of the members of the 42nd Infantry (Rainbow) Division of the United States Army. To further this purpose, the Trustees gave tentative approval to supporting the publication of Lise Pommois' manuscript on the Moder River campaign which includes the activities of Task Force Linden in Alsace.

Purpose b. Establish, operate, designate and/or support, maintain and subsidize monuments, museums, libraries, archives or similar exhibits of manuscripts, memorabilia and other items pertaining to, or having a significant connection with, the activities and the history of the 42nd Infantry (Rainbow) Division.

The Trustees were supportive of Archivist Bill Keithan's efforts to collect Rainbow memorabilia by establishing chapter achivists.

Purpose c. Seek, gather, accept, and administer monies to discharge the FOUNDA-TION'S activities in appropriately recognizing designated memorials, providing scholarship funds to deserving individuals, and fulfilling the FOUNDATION'S purposes.

Most of the individual opinions and much of the group discussions related to the variety of things the Memorial Foundation can do to perpetuate the memory of Rainbow and ways to acquire the money necessary to accomplish the purposes of the Memorial Foundation. Everyone agreed that the only way that the Memorial Foundation will be supported by the Rainbow men and ladies is to inform them how the money will be spent and how they can assist in raising money. It is planned that an informational brochure on the FOUNDATION'S activities, plans and aspirations will be available for distribution before the Pittsburgh reunion.
