Decorations & Awards

In individual conversations with many of our new members we have found that they are still unaware of awards they earned. We reprint the following derived from previous issues of the Reveille:

In 1947, the Department of the Army changed the identification of the Ardennes Campaign to Ardennes- Alsace. This campaign now covers the period from 11 December 1944 to 26 January 1945. It includes, in addition to Belgium, the Department of Alsace, France, including the fighting in that area in January and the units engaged in that area. Task Force Linden's operations there are covered in that campaign. If you were a member of Task Force Linden and participated in the January action, or were evacuated, wounded or sick or were captured while in that combat, you are authorized to take credit for that campaign.

Many Army veterans may be eligible for a Bronze Star Medal for service from Dec. 7, 1941 through September 2, 1945, if they meet one of the following criteria: If they were awarded the Combat Infantryman Badge or Combat Medic Badge.

A Soldier's Return

(continued from June issue)

On the far side of town was the place where Lt. Col. William Zeller had made his valiant stand with a hastily organized minitask force. With a few already decimated rifle companies, some machine guns and a few bazookas, he had moved forward from a point of woods on the north side of Gambsheim. Along the road, he met a group of five of our tanks withdrawing. When he told the tank commander to accompany his force, he was told that the tanks had orders to return to Hoerdt, and they thundered off to the rear. They might have made all the difference, not just by helping our left flank to succeed, but in driving the Germans back across the Rhine. If we had been able to cross the Rhine — why did they not stay?

In a short time, Bill Zeller had his troops formed into a skirmish line along the tracks. However, the German infantry was supported by Panzers. One of the Bazooka men hit the front of one of the tanks, just as it fired. Zeller saw the bazooka man's head go spiraling off. The tanks moved closer. The Americans were placed under direct fire. They had no chance. The defense of the left flank was over.

After taking some photos of that area, we looked for what may have been the head-quarters for Co. M's second machine gun platoon. Lt. Dutton, Frank Smith, and a dozen others had fought off the Germans for two days. They had only small arms and one or two machine guns and mortars. They were hit with everything. One house after another was set afire by tanks as they moved to another. In vain, the few survivors waited for a counterattack. Eventually, they had to surrender.

We could not find Dutton's headquarters, but did locate the pillbox where Sgt. Weidner and his machine gun squad had been trapped for three days. We passed some tennis courts, a soccer field, and then across a great spread of land, we saw a squat, round structure. As we drove over a bumpy, dirt road, the image grew. We could see the discolorations, peeling paint, the black rectangles from which the machine guns and rifles once fired, and the completely rusted turret.

We stopped the car and walked over to the still formidable and seemingly indestructible structure. Steel reinforced, two feet thick, and rounded for deflection of artillery shells. How quickly we had learned that it was a bitter, cruel joke for those who had to fight within them. With firing ports only on the side facing the Rhine, they were use-

less against attacks from the flanks or rear. and became prisons instead of forts. So it had been for Sgt. Weidner. His squad, two riflemen from Co. I, and two mortar platoon observers were cut off and surrounded for three days. They had only the water in their canteens and a No. 10 can of green beans for food. They were subjected to a constant rain of tank, artillery, and machine gun fire, but were able to hold off the Germans. The third morning, Weidner attempted to get back to our lines, but was immediately hit three times by machine gun fire. Two of his men rushed out and dragged him back. That afternoon, an American tank came up and, not knowing the pillbox was occupied by G.I.s, fired on them. One man ran to the tank and pointed out the Germans. Under cover of the tank fire, Weidner and his men jumped on the tank, and were transported back to Kilstett.

Battle of Gambsheim

We have gleaned from the National Military archives the following addendum to after action accounts of the Battle of Gambsheim. It was written by 1st Lt. Arthur Gottlieb-Historical Section-European Theater of Operations.

"So ended a tragic battle, one which unfortunately saw the participants come under their first baptism of five. Despite the outcome, no discredit can be brought upon them, for they fought on bravely against insurmontable obstacles for as long a time as they could. The final result was undoubtedly due to the apparent lack of intelligence, on the part of TFL as to the proper enemy strength and disposition. In addition, the need for a sudden hasty attack left no time for necessary planning, briefing of key personnel, or an all important reconnaissance of the terrain ahead of them, and what lay in it. The officers, as well as the men, were given the impression, at the start, that they would merely encounter a small enemy patrol which could quickly and easily be knocked out; they had absolutely no idea of the trouble they were to run into. The obvious lack of sorely needed vital support to accompany the infantrymen, in the form of tanks, large gun, and bazooka ammunition, to counter the German armor, stemmed from this erroneous G-2 information on the enemy situation. If they were on hand, quite possibly it would have meant a vastly different story at the end: success, instead of failure."

Rainbow Love

Many letters we receive are much too long to be entirely printed due to space limitations. The following is such a one. By shortening it, we believe we have not lost the import of this tribute by a son in memory of his Rainbow Dad.

"My late father, Harold Klemm, Bty. C, 149th F.A., participated in 6 major battles with the Rainbow in WW1, and was wounded in action. Although he never talked about the bloody part of his war experience, he did tell us of many amusing experiences. After he passed away, I found an old address book among his mementos. Between its pages was a well preserved poppy with the notation that it was taken in the front lines. This reminded me of the time my father hand picked the poem 'In Flanders Field' for me to recite to my 3rd grade class,

One more thing I found was a copy of a song I remember him singing: 'First they took us to Lorraine; Then we traveled to Champagne; Toot Suite to Chateau Thierry; Where we made the Huns look weary; Six days rest and we took St. Mihiel; Then we cleaned up the Argonne; But best of all Rainbow scaled the wall; That ran around Sedan That was some ball.

My father was a man for all seasons, as were all his Rainbow comrades in WW1 and WW2. Let us never forget that they unselfishly risked their lives so that we can live in peace and enjoy our freedom. May the Stars and Stripes forever fly over our country. I am most proud to be his son."

The Rainbow Memorial Foundation Trustees met twice during the Pittsburgh reunion. President Ivan Wallace was able to conduct the meetings despite a bout with a detached retina.

At the first meeting on July 12th, George Jackson reported that the Scholarship Committee had awarded ten \$500 first time scholarships for the fall term and had also awarded nine \$300 renewal scholarships to previous scholarship winners, for a total of \$7,700 in scholarship grants. The award winners are majoring in a variety of subjects at both large and small colleges and universities

Bill Keithan, Archivist, reported that a brief, or summary, of the history and objectives of the Memorial Foundation had been given to all the registrants at Pittsburgh. This Foundation document is a prelude to a comprehensive booklet, in preparation, that includes the Foundation history, objectives, constitution and by-laws, memorial locations, administration, funding, and also a wide range of suggested giving opportunities to support the Foundation objectives in perpetuity. approved by the Trustees. The audit confirmed a balance of \$104,128,74 in total Memorial Foundation funds, \$25,793.32 of this total is in the Scholarship Trust. The Budget Committee report was presented by Chairman Rube Evanoff and was approved by the Trustees. The budget for the next fiscal year is \$12,315, including the \$7,700 awarded in scholarships.
