#### FFI continued from the June issue

24 December: Christmas night means an unevent-ful round. When I come back at 6 o'clock in the morning. I am called by an American doughboy standing in front of the Kuhn's house, opposite the C.P. The medic needs my help upon entering the house, I find the maid lying on a bed, riddled with shrapnel, and the medic tries to extract all the metal pieces, one after the other. Julia Schnoering is holding her hand encouraging her. The American medic is a jovial man, and he starts joking with her and we burst out laughing which makes the situation even worse for the poor wounded maid, who starts groaning with pain and weeping. We remain pitiless. Then, seeing us laugh, the two young girls join in and it would be very funny if it were not for the wails of the maid. When I go home, I must take cover, several times, as our village is shelled for an hour by the German artillery.

25 December, Christmas Day: Our church has been destroyed, and religious services are held in the parish centre. Complying with our request, the vicar has agreed to say mass in our chapel, and has invited the American doughboys. I am his server. We are greatly impressed by the piety of the kneeling soldiers who pray with their arms stretched out and tell their beads.

27 December: We often go on patrol and try to find the four persons missing from Kilstett - to no avail. The news is bad, we hear a great battle is raging somewhere in the Ardennes, in Belgium. In fact, we learned later, the battle was almost over, but a new German attack was feared further down South, even in our sector. I often accompany American officers to organize the troops quarters. villagers come from time to time, and ask for gas. They offers schnapps or butter in exchange. This is part of my work as an interpreter. The American commander, a worthy man, is fond of me, and I can ask for his help at any time of the day or night. Today, something unpleasant happened to us. We were on night patrol, with American elements. Our friend, Joseph Febry, fired by accident and hit the leg of a doughboy. Joseph cries, bitterly, as we set up to his feet again, the doughboy who takes serenely. Since I am responsible for the patrol, it causes me a lot of trouble. I am questioned by an American military board after swearing to say the truth on the Bible . I try to cover my friend as much as I can, and given the most con-vincing arguments. The board eventually admits them. A few days later, Febry is taken prisoner. He will spend awful months in a underground camp. Several years later, he came and thanked me for what I had done. Who could refuse him anything? he and Eugene Raeppel formed a strange pair, so gallant and faithful. I am thankful to them all as they were always ready to help in these time of misfortune.

<u>30 December</u>: The Americans withdraw and it is said Alsace will be evacuated. About the strength of the platoon remains (Elements of Companies L, M, and Antitank, 232nd Inf.). We accomplished our daily task. Today we are pessimistic. We question Jung, but he gives us evasive answers and tries to comfort us.

31 December: Tonight, we celebrate the New Year. I'll be twenty tomorrow. What will th New Year bring? The American Lieutenant honors us with his presence. He looks worried and does not give precise answers. Is he usually like this or is there bad news? HERE ENDS MY DIARY.

1945 began with the almost complete withdrawal of American troops. Then, on January 5, a hurricane hit our village. I wake up several days later, dazed, on the hospital bed. A man from Gambsheim comes and my friends die tragically. I can see the baker, Alphonse Vix, in front of me, he already walks with crutches. I put down the names of some American doughboys who fell in our village. What a mixture of men of all origins: Joseph Patterson, Carroll Rollson, Dominic DeLuca, John T. Ratschak, Eugene Crabtree, John Gallegher.

Eugene Huss took part in the burial of John Gallgher. Does he remember him? We stopped for a minute in front of his body. He had his beads around his neck. And who remembers the time when we read the letter from a German woman to her husband in which she told him she had a baby daughter, and how sad we were looking at the corpse? We did not understand what was going on. One of us tore the letter away from the reader and shouted "stop".

Note: By Joe Neilson H-242nd Inf./John Gallagher (a good friend) was an ammo bearer in our HMG squad. He was killed instantly by exploding artillery shells as we lay a few feet from each other on the ice at Gambsheim 1-6-45.

### **Liberty Memorial Walk** of Honor

If you were at the National Reunion this past July and attended any of the meetings, you probably heard me talk about the "Walk of Honor" at the Liberty Memorial in Kansas City, Missouri.

The Liberty Memorial is conducting a Major fund raising project for the renovation of the Memorial and the "Walk of Honor" is a large part of this fund raising. The Liberty Memorial is the largest memorial in the country to honor those who did not return from World War I and was dedicated in 1921.

Our connections to the Memorial are threefold. The Rainbow Division veterans along with the 35th Division veterans raised a substantial sum for the development and erecting of the Memorial; the Hall of Flags located there was for a long time a Rainbow National Memorial until with the deterioration of the flags it was deleted from the list and as one of our six listed museums the Memorial houses one of our largest collections of Rainbow World War I material. The "Walk of Honor", will feature commemorative granite bricks, which can be purchased to honor those who served in World War I, World War II, any war thereafter or an individual who promotes the ideal of Liberty.

The brick sizes are as follows: 4"x8", \$100.00, with a maximum of 3 lines of copy, 8"x8", \$250.00, with 4 lines of copy and 16"x16", \$1000.00 with 6 lines of copy. Each line is limited to 15 characters of spaces.

Donations can be made by individuals, groups or chapters. At the Reunion \$1000.00 was donated by the RDVA Foundation, Auxiliary and the Artiliary chapter donated \$250.00 and there were three individual donations, one for \$250.00 and two for \$100.00 and battery "C", 392nd FA Bn has pledged a donation. I would hope we hear from some of the other Chapters: Infantry, Military Police, Signal, Medics, Quartermaster, Engineers, etc. and local or State Associations.

## Scholarship Committee Chairman Dottie Smith met with the

scholarship committee on Wednesday, July 7. There were 31 scholarship applications for the fall term, although funds for 41 were available. ### **42nd National Grand** Activities


The spring and summer for the Rainbow Division has been a period of intense training and preparations for a multitude of unit missions and exercises in 1999. The Division has accomplished everything from supporting National objectives overseas to military training here in the Northeast right down to community operations in local neighborhoods. The spirit of the Rainbow stretches over more than multiple states, the Rainbow stretches its capabilities over multiple missions and military needs.

While the armor and mechanized battalions of the maneuver brigades continue their pursuit of training excellence on gunnery ranges of Fort Drum, New York and the combat simulation cell at Fort Knox, Kentucky, Rainbow soldiers from other division elements expand the Division's scope of operations. Military Intelligence units provided analysis of data to support Defense Intelligence Agency operations in the Balkans. ### France Says Thanks To Soldier in WWI

Columbiana - Louis Trautman has seen a lot of history in his 102 years. Part of that history was his combat service in France during World War I. It was for that service that the French government will honor Trautman with its highest honor later this month.

Trautman is Columbiana County's last living WWI veteran. He enlisted in the Army at age 18 and served 31/2 years in France and Germany in Company D of the 166th Infantry, part of Gen. Douglas MacArthur's legendary 42th "Rainbow" Division.

The French government has named Trautman a Chevalier of the National Order of the Legion of Honor, France's highest national award.

In a letter to Trautman, Francois Bujon de l'Estang, French Ambassador to the United States, said the Legion of Honor is "a sign of the high esteem my country has for you who personally contributed to the decisive support the United States gave the French soldiers in the defense of their country during World War I."

A delegation from the French Embassy in Washington, D.C. will present Trautman with the Legion of Honor insignia in a ceremony at his home June

What happened: Trautman wa living in East palestine when he enlisted. He recalls he was among the first 25,000 American doughboys to go overseas.

He remained for several for several months in Germany at the conclusion of the war as part of the occupation force, which made him one of the last soldiers to leave Europe.

one point, his family Vandergraft, PA, believed he was dead. They placed a gold star in the window of their home and conducted a memorial

Eleven months after receiving a letter that he was missing in action, they received a letter from Trautman. He had survived an attack of mustard gas.

In combat: Trautman said much of his time with macArthur's Rainbow Division was spent in combat, fighting alongside one or two French infantry divisions.

'We were a unit unit, no doubt about

that," Trautman said. "We were always in danger."

He said MacArthur was a great leader who knew how to command and that "saved us a lot of trouble."

At home: Trautman married the former Mary Ruhl of Lisbon in 1926. They have one daughter, Mrs. Janet newton of Ann Arbor, Mich.

The couple settled in East Palestine, where Trautman built a home and a car dealership, which he operated for more than 50 years.

Trautman said that if another war like WWI broke out, he would "want to go, but I'm just not able."

### Actions of Anti-Tank Co./242nd Infantry At Hatten-Rittershofen, France-Jan. 9-12, 1945


(Taken from official records. This action earned a unit citation)

At 0001 hours., January 9, 1945, A company, 1st Bn. reported contact with an enemy patrol at a blown out bridge near pillbox #9. Captain Vincent Caringola, company commander of ant-tank company, alerted his 1st platoon, upon hearing this word. As his 1st platoon was supporting the 1st Bn/242, he proceeded to their C.P. to find out full particulars. At 0225 hours, Hatten was receiving heavy enemy artillery fire, all platoons of the Co. were fully alerted at 0400. At 0500, A Co. reported that enemy infantry was attacking in force. At once, Captain Caringola started back to his first platoon. At 0515, S/Sgt. Milmont squad leader of the third squad, first platoon who was at his gun position, reported this attack, by phone to Lt. Richard H. Wells and T/Sgt. Wallace A. Enge, that is squad was being fired on by enemy rifle and machine guns. Upon trying to call the 1st and 2nd squads, Lt. Wells found that communications had been broken by the preceding artillery barrage. He then directed S/Sgt. Milmont to check the remainder of his men to see that they were in position and all right, while he, Lt. Wells, checked on the 1st and 2nd squads. At 0530 hours S/Sgt. Milmont, T/4 Elmer Marshall, PFC. Joseph Loncaric, and PFC. E.L. Thompson made their way back to the gun position by crawling through the intense mortar and artillery fire, after checking on the LMG crew with the third squad. At 0535, Lt. Wells and T/Sgt. Enge contacted the first and second squads. They found these squads intact but receiving heavy mortar fire. At 0545, the Lt. and Sgt. started back to the third squad position, but on the way, they became aware that third squad position was untenable, because the enemy had infiltrated to within a few hundred yards of their position, and had captured an American TD, one hundred yards to their left front. . . PFC Raczkowski and PFC. C.L. Thompson had held off the enemy foot troops with a 30 cal. LMG up to this time. At 0600, Lt. Wells arrived at the third squad position by crawling and running through a hail of fire. The enemy turned the captured TD's 76mm. gun on the third squad. A direct hit by enemy mortars silenced the LMG. PFC. E.L. Thompson and CPL. Gullett brought the 57mm AT gun to bear on the captured TD, but a well aimed enemy rifle grenade landed on their position, wounding two members of the crew. The enemy kept coming and

when they were within 50 yards of the 3rd squad position, that squad, under Lt. Wells tried to get back to the edge of Hatten to fight from the houses.

At 0615, Lt. Wells, Sgt. Milmont, T/4 Marshall and PFC. Loncaric reached the edge of Hatten. Lt. Wells ordered the men to take some PWs to the rear and to contact Captain Caringola, on the way, at the Bn. C.P. They were to ask for further orders, while he tried to contact the 1st and 2nd squads. Capt. Caringola ordered the men to take up positions with the riflemen protecting the Bn. C.P. At 0720, the second squad was attacked by the enemy. With the aid of their 50 cal. mg., they were able to drive the enemy off. At 0800, Lt. Wells, having contacted the 1st and 2nd squads, returned to the C.P. Capt. Caringola told Lt. Wells to go to the third platoon and have them move their two right flank guns to help the third platoon. At 0820 hours, the third squad the third platoon (the left flank gun), saw four enemy tanks coming from the woods to their extreme left front, heading towards Hatten. The third squad's field of fire had been, originally, coordinated with the fire of the two M18 TDS, and was not in position to fire on the enemy tanks. The TD sitting near them had been abandoned. S.Sgt. Richard R. Danilowski, knowing that his gun was the only weapon in a position to prevent the enemy armor from penetrating the first 1st Bn. lines, moved his gun from the prepared position into the open, under artillery fire, and opened up on the enemy tanks at 0825. Although the nearest tank was 800 yards away, one enemy tank was destroyed, and the rest driven back into the woods. At 0900 enemy personnel carriers and tanks began coming from the woods ... Lt. Raymond L. Kiplinger, Jr., third platoon leader, came from right flank gun, at this time, and the 57mm gun was again moved to a more advantageous position, under artillery fire. This time, a personnel carrier and it's occupants were destroyed with the ammunition. The rest of the enemy vehicles veered off to the right and were soon out of range. At 0915, Lt. Kiplinger noticed that the third squads ammunition was running out and that the squad would need help. He took off, in his jeep to get ammunition and assistance from the the other two squads. At 0925, T/Sgt. Enge, who had been fighting with a rifle squad, reached a position where he saw the 2nd squad of the first platoon firing their 50 cal. mg. at enemy troops within a hundred yards of them, and S/Sgt. Joos directing fire of their 57mm gun at the enemy tanks which had veered away from the third platoon. A heavy concentration of mortar shells was falling between Sgt. Enge and the second squad, making it impossible to reach them. One enemy tank was hit before enemy infantry overran their position T/Sgt. Enge had picked up an SC300 radio at the C.P. He now took it to the 1st squad of the 1st platoon and established communications at 0945 hours. Lt. Wells contacted Lt. Kiplinger on the right flank of the 1st Bn. and told him what had happened in Hatten and that he could move his two guns to the left flank to help his 3rd squad. Lt. Kiplinger told Lt. Wells that ammunition was critical and any help in that area would be appreciated. Lt. Kiplinger directed T/Sgt. Lindsey to move the two guns, and with a jeep load of ammunition, started back to his other gun. Stopping on the way, he phoned 1st Bn. commander and asked that ammunition be sent to him. At 1000, Capt. Caringola, seeing that tank support was needed badly, went from Hatten to Rittershofen, under heavy enemy artillery fire, in order to contact a Co. of the 48th Tank Bn. While there, he contacted Lt. Danny McBride, platoon leader of the second platoon, and ordered him to go forward to reconnoiter for positions on the west edge of Hatten and to move to Hatten as soon as possible. Lt. James V. Yates, mine platoon leader, who was at the Co. C.P. in Betschdorf, hearing of the situation, ordered the A Co. kitchen truck to be loaded with mines and brought forward while he searched for a position for a mine field to day armor penetration into Hatten. At 1030, Capt. Caringola returned to the 1st Bn. C.P. where he saw Lt. Wells, who informed him of the ammunition shortage of the 3rd platoon. He told the Capt that he had a truck load of ammunition to take to the 3rd Platoon. At 1045 Lt. Yeates arrived at the C.P. and he and Capt. Caringola decided to lay a hasty roadblock across the main street of Hatten near the church. At 1055, the Capt. sent Cpl. James Derry to Rittershoffen to pick up two daisy chains which had been laid there.

Kansas City is undertaking a \$100 million dollar renovation of their Liberty Memorial, that was once an important part of Rainbow memorials from WWI. They are selling paving stones around the Memorial to veteran's organizations and individuals which can be inscripted with a dedication to individuals, units, etc. The Foundation Trustees voted to purchase a \$1,000 block that will be a Rainbow memorial for both wars. Charles Fowler and Herb Butt will coordinate unit & individual

purchases of paving blocks.

## NEW PLAQUE FOR WAMPEE PLANTATION HOME FOR THE FOUNDATION

We are hoping to have a rededication of the plaque that was originally placed at Wampee Plantation, Moncks Corner, South Carolina in 1973 as the birthplace of the Rainbow Division Veterans Memorial Foundation in 1971. The building that the meeting was held in was demolished by hurricane Hugo and the plaque disappeared.

As we are still in the process of putting this all together, we do not have the final plans. Tentatively we are looking at October 27, 1999 for this ceremony.
