There were close to 600 Rainbowers who enjoyed our reunion on July 10-13. 2002 at the Marriott Southern Hills Hotel in Tulsa, Oklahoma. It was probably our last chance to return to our old stomping grounds. On July 10, a total of 416 (7 busloads) climbed aboard for our Camp Gruber trip. Our first stop was at Honor Heights overlooking the Cookson Hills and Camp Gruber for a rededication ceremony. Charles Fowler, our Memorial Officer, conducted affairs in the blistering heat, reminiscent of training days. He introduced Father Weiss for the invocation. Then Ted Simonson, President gave us a talk surrounding the history of the first dedication. We were then welcomed by J. Mark Wilkerson, Director of Muskogee Parks & Recreation, and the Mayor of Muskogee, Hershell McBride. Rededication then was conducted by

Rick Ewing (recreation) and Rainbowers Al Cahoon and Bob Haggard. Father Weiss followed with benediction. We then traveled to Muskogee for lunch and on to Camp Gruber. Very few of us could identify very much as all the old barracks are gone.

Here, at Camp Gruber, we installed a plaque, donated by the Ladies Auxiliary. We had the invocation by Father Norman Forde and Charles Fowler led us in the Pledge of Allegiance stressing "Under God." Mrs. Cindy Shaver, wife of Major Shaver, acquainted us with the history of the plaque, and Auxiliary President Grace Walker presented the plaque to be placed in Headquarters. Ltc. Ronald Ragland, Deputy Commander of Camp Gruber, made an acceptance speech. Benediction was given by Father Forde.



# The Luckiest G.I. in the E.T.O.

(continued from the June issue)

The brass got around it by court-martialing Frenchy and me by charges of consorting with residents of an enemy nation. Oh well... I lost \$15 and a stripe.

We would drive a mile or so and stop to see if we were needed and then proceed. Lo and behold! What did I see were my homemade phones by the side of the road. Someone had picked them up and discarded them.

At Schweinfurt, some G.I. rescued a small dog which had been tied to an 88. He gave the dog to me and he rode under the dash by my foot most of the time. He is in a picture on page 98 of the Division History. At war's end Lt. Duke and some other officers had me drive them to Chiem See and we took a boat to see King Ludwig's castle. We made several more moves in Austria. My sister, who was in the Red Cross, looked me up and we drove up to Hitler's redoubt. Major Deane took me as his driver and I had to put on O.D.s in the evening, sitting and waiting in the Jeep while he lived it up at some chateau. One night of this was enough. I was able to get transferred to Salzburg. I was later sent to Vienna and joined K Co. as guard driver... five happy months of detached duty. I had an assistant so I didn't have to drive all the time.

Later, I was sent on a vagabond tour to Italy with 10 GIs. Going through the Brenner Pass, I met an English soldier who had a broken fan belt. Luckily, I had a spare. We traveled to Lake Como, hitting one cow on the way. Going down one side of the lake, my trailer tire went flat. The Dodge spare didn't fit the GMC trailer. A local mechanic fixed it for a carton of cigarettes. We got back to Vienna OK. One morning I had four cans of gas: 3 jeericans and one G.I. I poured it all in and guess what? 5 gallons of water from the G.I. can. Everybody but me had left by the time I had things fixed up I had to drive like crazy to catch up. We left vehicles in the mud somewhere. We left for Bremerhaven to N.Y. and home.

# Rainbow Division Serving Proudly in 2002

Soldiers from the Army National Guard's 42nd Infantry Division who have successfully completed their support to homeland defense following the terror attacks of September 11th will quickly transition this spring and summer to a renewed focus on the Rainbow's federal mission to fight and win the nation's wars.

After thousands of Rainbow troops supported recovery efforts in New York and the nation this year, those same soldiers who provided security at ground zero, at the nation's airports, northern border, or at critical sites throughout the nation return to their traditional Army role as combat soldiers preparing for possible deployment overseas.

This year the Rainbow division that spans eight states will show the Rainbow patch stretch across the nation and parts of the world as National Guard troops conduct training with a renewed vigor and enthusiasm after their experiences in the nation's war on terrorism.

Those same Rainbow soldiers seen on the streets of New York City or throughout the nation will now appear on the tank ranges of Fort Drum, NY and Fort Dix, NJ. Tank crews and infantry soldiers will return to the basics and conduct individual and crew weapons qualifications. Artillery cannons will again conduct livefire and training in places like Fort Irwin, CA and Germany. Engineers will conduct their training at Fort Drum and Camp Edwards, MA. Logistics and support troops will deploy for training to Germany or Nicaragua. Air Defenders are scheduled for a live-fire Stinger gunnery at Fort Bliss, TX, support missions to Fort Polk, LA and Camp Chaffee, AR and a field exercise at Camp Atterbury, IL.

The Rainbow Headquarters will support two other major exercises. In June, the division and its 86th Brigade headquarters (The Vermont Brigade) will host hundreds of European NATO partners and non-aligned senior military leaders for a Joint Forces Command exercise called "Cooperative Nugget 2002." The division and the Vermont Brigade will conduct a battle simulation for peace operations to rehearse NATO procedures alongside their European counterparts. In all, 20 nations will participate and Rainbow soldiers will deploy elements to overseas locations to conduct the battle simulation.

In August, the division headquarters deploys for its own battle command evaluation known as the Warfighter. Held at Fort Leavenworth, KS, the exercise will train the division's leaders and staff on battle plans, communications, reports, and coordination of battlefield operations.

In all, the Rainbow is the only Army combat division supporting the country in every role designed for a National Guard unit. Soldiers continue their support to New York City on state active duty while hundreds of other Rainbow soldiers remain on federal duty for security at key sites such as military depots, arsenals, or the Military Academy at West Point. Still other 42nd Division soldiers work alongside the border patrol and customs agency at the nation's international borders.

Whether serving their local community, their state, or their country, the men and women of the Rainbow today continue the proud legacy of success in the Rainbow.

# Rainbow Support to the War on Terror

Almost nine months after the terror attacks at the Pentagon and the World Trade Center, men and women from the Army National Guard's 42nd Infantry Division continue their state and federal service that began right with the initial attack at the World Trade Center in lower Manhattan

While the majority of support from the Rainbow came over the first critical weeks and months of New York City's recovery efforts, soldiers of the 42nd Division continue to assist the New York City Police Department and Port Authority Police in securing key rain stations, bridges, and tunnels into Manhattan.

At the same time, federal mobilization orders arrived for the 1st Battalion, 69th Infantry Regiment, the Rainbow's historic "Fighting 69th." More than two full infantry companies were called to active duty to provide security support to the nation's critical sites, including the West Point Military Academy.

The Fighting 69th soldiers were

among the first National Guard troops to arrive at the World Trade Center, troops from the NYC-based battalion helped with the initial rescue efforts. Alongside their fellow Rainbow soldiers from the 1st Battalion, 101st Cavalry and the 1st Battalion, 258th Field Artillery and other New York National Guard units, the Rainbow men and women became the foundation for New York's military response to the terror attacks of 9-11.

All told, thousands of Rainbow troops descended upon New York City. The division headquarters itself deployed to Manhattan as the Joint Task Force headquarters, commanding the elements from the Army National Guard, Air National Guard, NY Guard, and the NY Naval Militia, including a contingent of Navy Reserve Construction Battalion (SeaBees) and Marine Corps Reservists. The 42nd Division's 3rd Brigade, Aviation Brigade, and Engineer Brigade all provided support to the mission in New York.

Throughout the Rainbow, 42nd Division soldiers rose to the challenge. In New Jersey and elsewhere, soldiers assisted in the airport security mission on federal duty. Along the northern borders, soldiers from New York and Vermont deployed alongside the U.S. Customs Agency.

The efforts of the Rainbow continued throughout the winter and through today. Rainbow soldiers provided a color guard for the New York City six-month commemoration ceremony and temporary memorial dedication at Battery Park in lower Manhattan. Soldiers from the Fighting 69th received special praise during the city's St. Patrick's Day parade in Manhattan and received a special place of honor at ground zero on the May 30th final ceremony marking the end of recovery efforts at the World Trade Center.

As the nation continues to be vigilant and supportive of the war on Terrorism, the citizen-soldiers of the Rainbow Division continue to prepare to refocus their efforts on their service to the Rainbow, the Army and the nation.


