Ted was the youngest of four boys. Consequently his draft board was against drafting him. However, Ted fooled them and enlisted.

Ted was one of the ASTP students from Fargo that was transferred to the 42nd Division. He served in the 81 mm Mortar Section and was discharged as a S/Sgt with the Combat Infantry Badge, Silver and Bronze Star Medals.

He was an Iowa College graduate with a law degree and had retired from J-Tech Industries after years of service. He has been Senior Past National President for the Association, now Foundation. He served RAINBOW over the years in many positions — all the way from Chapter Secretary to National President during the 1964-65 Membership year. He was Judge Advocate for years and will long be remembered as the MC that so ably conducted the Champagne Hour.

Ted is survived by his wife Shirley, daughters Julia Sturgeon, Ely, IA and Jeannie Prince, Dallas, TX; Sons Jeff, Oleweine, IA and Jim, Cedar Rapids, IA; as well as seven grandchildren.

Earnie Owen sent us an e-mail saying that "Al Cahoon, 242 A Co., passed away January 26 at the VA hospital in Muskogee, OK. He had an upper respiratory infection and was just too weak to fight it off. There was a graveside service at the Ft. Gibson National Cemetery," January 31 at 1 p.m.

Al was born on the 4th of July, 1918; was at Scofield Barracks, Hawaii on Dec. 7, 1941; became one of the cadre men at Camp Gruber (summer 1943); platoon Sgt. A-242; captured at Hatten, Jan 9, 1945; postwar, he organized the 242 Chapter and presided until our charter was granted in July 1976 but would not run for chapter president.

Throughout the years, he was a generous contributor to Rainbow, including the Auxiliary and a number of chapters. He quit traveling many years ago, but he participated in some of the nearby Honor Heights ceremonies at Muskogee.

My Friend from Schweinfurt

In the year 1943 I heard that we had lost 40 B-24 in the raid of a German factory located in Schweinfurt, Germany, I never though about it again until 1945 when as a BAR (on of two in our squad) we attacked Schweinfurt in the early dawn. I remember when we were in formation walking very quietly and we must have been successful because we passed several German soldiers in trenches asleep. They gave up with out a fight because they were totally surrounded. I remember walking by the concrete fortification of their anti aircraft guns. This is where I saw stacked on end all the B-24's that were shot down in 1943. It was a very sobering time of my life. We laid down on the edge of a railroad taking up firing position while we waited for the other regiment that we learned was pinned down by machine gun fire. One of our tanks was sent to take care of the machine gun nest. We followed and when the tank was returning the tank driver said do we want a ride back. When we were climbing on I heard one of the crew men say, get on as many as you can as that will be that much protection for us. I did them one better because I climbed down inside the tank. We then were deployed at another part of the railroad or maybe it was a spur but we lay down on the tracks and open fire on the German's that were trying to escape. We got several prisoners at that location. We were told to go from building to building and flush out the enemy. In the process I went to the front window to see what was going on as I was in the process of removing the front shutter so I could see-a large explosion occurred right in front the building I was in and the window blew in my face. My ammo bearer was with me naturally and I turned and ran right over him. As it turned out it was a Long Tom firing from a flat bed car on the railroad a few miles away. The Long Tom, that's what they called back then I don't know if that is the correct pronunciation, but was German largest gun or artillery mounted on a flatbed. The German's fired a couple more rounds and we were running between the building and we came to a court yard and the only way we could get to it was through a small opening in the brick wall. We jumped through the opening. I threw a BAR through the opening and then I dove through. The Captain was in our group and Jumping Joe, the name that we pinned on him-went up in the top of the building and called for our artillery to fire on the Long Tom and it was knocked out the first barrage. There sure was some scared GI's and I was one of them. I can remember that I was in a crater for a fox hole when the word came down that President Roosevelt had passed away and we had a gathering pray. That is my recollection of Schweinfurt, Germany.

Hello, my name is William Maynard. I would like to know if you could put an ad in the Rainbow Reveille. I am doing research on the 232nd Reg. 3rd Bat. Co. K. It seems that men of this Co. were issued the French Croix de Guerre award; My grandfather was one of them. His name was Herbert E. Sharkey. I have spoken to several vets that were in this Co. and were also issued this award. It seems to be a unit citation. I would like you to run an ad to see if I can locate any other veterans that were also issued the Croix de Guerre. I have one veteran by the name of Walter Smith that sent me a copy of his separation paper that lists this award and a photo of his Ike Jacket with the Fourragere of the Croix de Guerre on the left side. The vets that I have spoken to that confirm the award and were also issued it are Herbert E. Sharkey, Boyden Wells, Lenwood Ashcraft, Walter Smith, John Ballard. I am looking for any information that anyone could provide. It was issued between the months of June 1945 and November 1945 in Austria. It seems there is no record of this award being issued and I would like to have it recorded in the archives so these men can be remembered. They can contact me at my address, which I will enclose. I would like to thank you for your time. Could you please let me know it you can run this ad for me.

Dear Ken,

When we spoke on the telephone yesterday, you suggested that I write you requesting information about the events around my uncle's death in WWII. His name was Pfc. Arnold Reed Dollarhide, and he was killed in action during the battle of Ohlungen Forest on January 26, 1945. I would like to add this information with other personal effects from my uncle, in order to keep his memory alive in our family for generations to come. Our family at one time had a book which described the battle in some detail, and specifically mentioned him by name. It described how shortly before his death, he went out on patrol in an armored car. They encountered Germans and took some prisoners. Afterward they took the prisoners back to a company headquarters in Neubourg. An artillery shell exploded near the headquarters building, killing my uncle and one of the prisoners. This account may have been described in a book entitled, 42nd Rainbow Division: History of World War II, by Hugo C. Daly. I would very much appreciate a copy of the pages describing these events if you can possibly locate them, and of course would appreciate anything else you can find about him. I hope the following information will help you locate the information about him:

My husband, the late Edwin A. Schlapbach, (May 26, 2002) served with the 42nd Rainbow Division during World War II. He was also a prisoner of war. He was captured in January 1945 and was held at Stalag 9 near Bad Orb, Germany.


He told me that he and the other prisoners sang a song to the tune of "Battle Hymn of the Republic." I cannot remember what he told me and he couldn't remember the exact words, but part of it was "Come and get us Georgie Patton, Come and get us Georgie Patton so we can ramble home. We're a bunch of soldiers...deep in Germany, Come and get us Georgie Patton." But, there was a lot more to it. I was wondering if anyone happened to be there and if they remember the words to their song. I would like to know it so I can pass it on to my grand-sons

Also, before my husband died he told us that people, especially military, should have taps played and then just at the end of the services at the cemetery, they should play reveille. He said that when reveille is played, it would be like a "new morning" or "getting up to a new morning" Anyway, we thought that the military unit was going to do this, but then they said that they were not allowed to do it. We were discussing it as we left the cemetery in the hearse and my grandson said, "Well, I have it on my cell phone." So, he played it on his cell phone. And my husband got his wishes anyway. But, I still think it was a good idea.

So, if anyone does remember the song, I would appreciate a copy of it.

A Spiritual Soldier's Salute

WATERBURY, CT — With a blend of solemn military honors and upbeat evangelical fervor, Staff Sgt. Henry E. Irizarry was laid to rest on Dec. 14, 2004. Irizarry, a member of that 1st Battalion 69th Infantry Regiment of the New York National Guard, was killed Dec. 3 in Taji, Iraq, when a roadside bomb detonated near his vehicle.

"The greatest soldier there ever was in all the world, and he still exists, is Jesus Christ," said the Rev. David Torres, pastor of Aposento Alto Pentecostal Church.

In a rousing 15-minute sermon on resurrection, met with applause and shouts of affirmation, Torres preached that Irizarry, a devout Pentecostal Christian, had gone to rest in heaven because he was "spiritually prepared" to die.

"I know and I am sure that the soul of my brother very happy," Torres said.

Services were conducted in English and Spanish, with translations provided simultaneously by the Rev. Roberto Rodriguez.

Irizarry joined the church in 1999 and quickly became a leader within the congregation of about 120 members, teaching Bible classes and assisting with other church functions.

During the services, Irizarry's widow, Jessica, broke down briefly during a musical interlude in which mourners were exhorted not to cry. Otherwise she maintained the same quiet composure she'd exhibited publicly through most of the nearly two weeks since her husband's death.

At the end of the service, she spoke briefly to the congregation, her remarks translated into English by an inter-

preter, saying she still did not understand why God would call her husband home, but that she hoped in time to comprehend the greater plan.

About 20 members of Irizarry's military unit still serving stateside came to the services in First Assembly of God Church on Thomaston Avenue to serve as an honor guard for their fallen comrade. Irizarry was the third member of the unit killed in Iraq since its arrival in late November.

Flyboys of Vietnam, Gray and Gazing at Iraq Sky

FORWARD OPERATING BASE DANGER, Iraq, Feb. 20—The seasoned pilot was recalling a different war in a different place: "Every time we went in, we went in hot," he remembered. "You were fighting your way in and fighting your way out."

The pilot, Chief Warrant Officer James G. Freeman, was 23 when he began flying Huey helicopters in the Vietnam War in 1970. His missions with the 116th Assault Helicopter Company often involved dropping into a battle-ground to unload soldiers after helicopter gunships had "prepped" the zone with a torrent of rockets and machinegun fire.

"There were a lot of bullets flying down there," Mr. Freeman recounted dryly during an interview. He was seated in a trailer on the airfield at Forward Operation Base Speicher, an American military base near here and his home for the next year while he is deployed with the 42nd Infantry Division of the New York National Guard, based in Troy, N.Y.

Mr. Freeman is now 58, with wry creases spraying from the corners of his eyes and a penchant for menthol cigarettes. As a member of the Guard, he has been deployed for events including the 1980 Winter Olympics in Lake Placid, N.Y., and relief and recover missions after the 1993 World Trade Center bombing, the crash of T.W.A. Flight 800 in 1996 and the attack on Sept. 11, 2001.

Now, 34 years after his yearlong tour of duty in Vietnam, Mr. Freeman is back in another war.

He is one of five helicopter pilots from the New York National Guard who flew Hueys in the Vietnam War and who have been deployed as Black Hawk pilots in northern Iraq with the 42nd Infantry Division. The five pilots, all together, flew thousands of combat hours in Vietnam and survived being shot down several times. In this war, however, they say their responsibilities have kept them largely earthbound, as younger pilots rack up the flight hours. And they are not very happy about it.
